



2024 TGOR Rules

- Limit of 3000 tickets to be sold numbering 0001 to 3000.
- Each ticket is a \$50.00 donation. Tickets will be sold beginning September 3, 2024 through October 22, 2024.
- By obtaining a raffle ticket you attest that you are a law-abiding citizen of good moral character, may legally possess the firearm(s) won, have intention of using the firearm(s) only in a legal and safe manner, release Morgan Academy from any and all liability, and will or have already obtained instruction on the safe use and operation of the firearm(s) won.
- A ticket will be drawn for each day from **November 1st** through **November 30th** with oversight by an external CPA.
- A specific gun is assigned to each day of the drawing. The winner on a particular day wins the gun assigned to that particular day. A schedule of guns, dates and pick-up location will be posted prior to the **November 1st** drawing.
- Winning tickets drawn will be re-entered in the raffle. Each ticket represents an opportunity to win thirty (30) guns and a grand prize.
- Each winner during the 30 days drawing will also be entered in a final drawing for a grand prize to be drawn at the end of the 30 days.
- All firearms won are subject to availability and MA reserves the right to make substitutions of equal or greater value.
- Winners and firearm won will be posted on the MA website and the winner will be notified by email or phone.
- Proceeds of The Great Outdoors Raffle will assist with academic, technology and maintenance initiatives of MA.
- You must be at least 21 years old and a legal resident of the United States to purchase a ticket.
- Winners will be notified, using the name, address, email address and/or phone number, that the purchaser has written or requested to be on the ticket stub. In the event that MA is unable to contact the winner, it is the sole responsibility for the winning ticket holder to contact MA to claim his/her prize. Prizes are not transferable; the person designated on the ticket must claim the prize.
- **ALL PRIZES MUST BE CLAIMED AND TRANSFER COMPLETED WITHIN 90 DAYS OF THE SCHEDULED DATE THE TICKET IS DRAWN. UNCLAIMED PRIZES WILL BE OFFERED FOR RETAIL SALE.**
- Raffle is void where prohibited.
- All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply.
- All firearm transfers will be administered through Rountree Outdoors, Central Alabama Farmers Co-Op or designated FFL. All applicable Federal and State laws will apply, including the state laws for the legal residence of winning ticket holder.
- In the event winners need or wish to have the firearm(s) won transferred to their local FFL dealer closer to their residence, shipping and any other additional costs involved with the transfer will be the responsibility of winner and arrangements must be made directly with Rountree Outdoors, Central Alabama Farmers Co-Op or designated FFL.
- All pistol winners that are not Alabama residents will be required to ship and transfer to their state of residence. All fees are the responsibility of the winner.
- Winners may be required to verify that ownership of the firearm(s) won is legal in their state, city or town, prior to taking possession of won prize(s).
- At no time will MA take possession of any of the firearms involved in this raffle; winners will receive firearms directly from Rountree Outdoors, Central Alabama Farmers Co-Op or designated FFL; all applicable laws will apply.
- MA limits any and all liability to the purchase price of ticket purchased.
