**B.** Superintendent Search Process Update, Facilitated by McPherson & Jacobson, LLC, packet provided to the Board:

Mr. Nelson joined via zoom and Mr. Scott in person

- b. Preview packet will be sent to you prior to interviews.
- c. Over 100 participants in survey
- d. Mr. Nelson went over the survey results, results provided to the Board

Discussion: 101 responses is good? Willamina had 70 ish, Grants pass had 125-150.

e. Went over proposed interview schedule, need to change Tuesday to Monday

**Discussion:** How do we gather feedback from the community Q & A, Cards? You will get that info as you will still be in deliberation. We use a generic old school form. We the board will meet after each interview? Yes. Yes the same questions need to be asked, however you can ask a clarifying question.
