- Must be currently unemployed or underemployed.
- Must be 18 years old or older.
- 100% attendance is required to complete this six-week program. You must be on time every day. Being at work and on time is part of your job
 training. Attendance records are part of the course records and provided to prospective employers.
- Must possess a high school diploma or GED.
- Must be willing and able to work full time in a manufacturing environment upon completion of this program. This includes the ability to stand or sit for long periods of time, and work holidays, weekends, and /or night shifts. Reliable transportation to/from class and work is required.
- Must be willing to provide contact information during the program and for three months following the close of the program. This is for job
 placement and follow-up required for funding.
- Athens Technical College is a smoke free and drug free campus. Manufacturers require drug screenings and physicals as part of their hiring process.
- Ability to stand and sit for long periods of time (~8 hours at a minimum)
- Ability to push, pull, lift, or carry 10-15lbs on a consistent basis
- Manual dexterity, particularly in the hands
