# **Curriculum and Instruction**

Mrs. Roberta Cumbee, Executive Director of Curriculum and Instruction, asked for questions relevant to the Board Agenda attachment from the Office of Curriculum and Instruction. She addressed a question regarding Benchmark Testing, assuring the Board that results from Benchmark testing are being used by teachers throughout the year as a key to improve student achievement.

#### **Student Services**

Dr. Brian McKnight, Director of Student Services and Transportation, addressed Board Member concerns as follows:

- The number of students on the disciplinary report included hearings held during the months of December and January.
- Intervention is being provided to students, especially repeaters. Behavior intervention plans are implemented by teachers to stop problem behaviors at school and increase classroom productivity.
- Ms. Brock stated that the administration is working providing professional development for teachers on ways to keep students actively engaged in learning, and not being disruptive. She stated that when students are sent to the principal, it's the last resort. She also indicated that there has been a decline in disciplinary infractions from the prior year.

# **Finance and Administrative Services**

Audit Report

Mr. Marc Woods, Auditor, with Sheheen, Hancock and Godwin presented the Executive Summary of the 2016-2017 Audit to Board Members, and allowed for their questions and concerns. He commended staff members of the Finance Department for receiving an "Unqualified Audit" which is a complete audit that analyzes both the internal system of control, as well as all of the details in the finance department's books. Mr. Woods noted that the fund balance will cover over one month's expense; however, the State Department of Education recommends a fund balance that covers 3-6 month's expenses.

# **Expenditures and Revenues Statements**

Mrs. Wendy Fulton, Assistant Finance Director, asked for questions pertaining to the expenditures and revenues statements.

Ms. Brock updated Board Members of the following projects:

- The C. E. Murray High School roofing project is proceeding according to its projected schedule for completion in March 2018.
- With reference to the property donated to the Veterans of Foreign Wars the property has been surveyed and the administration is waiting for the preparation of the deed.

Four members abstained from voting: Rev. Alfred Darby, Mr. James Dukes, Jr., Ms. Angela McClary-Rush, and Dr. Kerry Singleton. The motion to deny an appeal hearing was carried, (5-0-4).
