2023-24 School Description and Mission Statement

Indian Valley Intermediate School is located in Stonyford, CA and is approximately 20 miles south of Elk Creek. IVIS houses grades 5-8 and is staffed with two teachers and one para educator. Food services is delivered from Elk Creek. The class room ratios on average are 13:1. The 7/8 grade class participates in the the Elk Creek High School FFA program. The high school FFA advisor travels to Indian Valley once per week to work with the middle schoolers.

With such a small school, academic and emotional support can be provided much more efficiently than in larger schools. The academic counselor from the high school supports students with academics as needed and prepares 8th graders for their high school transition. Mental Health is supported through two clinicians through Northern Valley Indian Health and one mental health clinician through Glenn COE. All schools in the SCJUSD are well suited for families and students who enjoy a small school setting.

The Maintenance Lead conducts regular inspections for the buildings and grounds and formal inspections each December and all school staff are encouraged to report any concern to the administrator immediately. The facilities were built in approximately 1950 and have been maintained in good repair, using both the expertise of maintenance personnel and licensed contractors. The maintenance and custodial staff take pride in keeping the classrooms and other areas of the campus in good repair and in a manner that meets high standards for cleanliness. Janitorial services are provided on a regular schedule by personnel trained in the use of appropriate cleaning products for a school site.
