Construction Project Mr. Smith shared the construction updates, there are still cameras to be installed and intercoms to be linked up. Looking at soundproofing the weight room as it can be really loud at times being next to the computer lab. Next month we should be finalizing the construction project. Septagon will be honoring a one-year warranty once the project is completed for anything that might come up during such time.

Administrator Reports Mr. Smith shared the preschool playground has had the concrete track poured, playsets have been placed, but not yet anchored down. Mr. Smith is working on adding a few other equipment items to the playground, and looking into adding rubber mulch in place of the rock. The storage building by the south entrance of the football field is to be moved closer to the playground as that stores outdoor items for preschool. Mr. Smith shared that the start of the school year is going smoothly, bus routes are running smooth as well.

Mrs. Eckhoff shared that current elementary enrollment is 284 with attendance at 97%. After school tutoring started today, along with Discover classes began for afterschool groups. September 30<sup>th</sup> is a staff work day that elementary staff will go over the Star reading assessments that are coming up, the first mid-quarter testing began today, and student picture day is coming up October 2<sup>nd</sup>.

Mr. Curtis arrived at 7:20 from JH Football game.

Mr. Curtis shared that current high school enrollment is 250 with attendance at 94.23% currently. Mr. Curtis shared recent activities and sporting events. Student Council and Community National Bank recently held a tailgate party this past Friday, September 13<sup>th</sup> before the Homecoming Football game, the movie after the game was well attended by our students. JH Volleyball recently hosted a tournament this last weekend, we had 10 teams attending, HS Volleyball runs this tournament and had many compliments. JH Football started their season at home tonight.
