**SUBJECT:** Kindergarten and Seventh Grade Immunization Status Report 2017–18

### INFORMATION ONLY

Each October, all public and private schools with a kindergarten or seventh-grade are required to submit reports indicating the immunization status of their kindergarten and seventh-grade students. This information is compiled and sent to the Immunization Section for tabulation. Enclosures 1 through 4 are summaries of kindergarten data and enclosures 5 through 8 are summaries of seventh grade data. This year's report reflects immunization coverage for 222,397 kindergarten students and 232,080 seventh-grade students.

**Purpose:**

- Decrease the occurrence of vaccine-preventable diseases by increasing immunization coverage levels among school-age children.
- Emphasize the importance of immunizations to our community partners, including public, private, and parochial schools.
- Ensure the enforcement of Chapter 64D-3.046, Florida Administrative Code and section 1003.22, Florida Statutes, regarding immunization. Florida law states students may not attend school without proper immunization documentation. Schools permitting students without proper documentation are in violation of state law. Schools should exclude those students from school until proper documentation is provided. (Exceptions: schools may issue temporary [transfer] exemptions for up to 30 days for students transferring from another county; homeless children; juvenile justice system entry; and children of military families, as defined in section 1000.36, Florida Statutes).
- Identify those counties needing assistance in raising immunization coverage levels in kindergarten and seventh grade to Florida's goal of 95 percent. The national goal for kindergarten and seventh grade coverage is 95 percent and 90 percent, respectively.

**Results—Kindergarten:**

Statewide, 93.7 percent of kindergarten students were reported as receiving all immunizations required for school entry/attendance. This includes:

- Four or five doses of diphtheria, tetanus, pertussis (DTaP) vaccine
- Three, four, or five doses of polio vaccine



- Two doses of measles, mumps, and rubella (MMR) vaccine
- Three doses of hepatitis B vaccine
- Two doses of varicella vaccine

Of Florida's 67 counties, only 32, or 47.8 percent, achieved or exceeded the 95 percent state goal of kindergarten students receiving all required immunizations upon school entry/attendance. Statewide, only 280 students, or 0.1 percent, had inadequate immunizations or inadequate documentation of immunizations. Students with exemption from immunization accounted for 6.2 percent of the total kindergarten population as reflected below (Enclosure 1):

- 6,800 temporary medical exemptions, or 3.1 percent
- 1,051 permanent medical exemptions, or 0.5 percent
- 5,394 religious exemptions (RE), or 2.4 percent
- 549 30-Day exemptions, or 0.2 percent

The statewide RE rate in private schools is more than twice that in public schools, with 4.6 and 2.1 percent respectively. Thirty-two counties (48 percent) have a RE rate  $\geq 5$  percent in their private schools, compared to only two counties (3 percent) in their public schools (Enclosures 2 and 3). The RE rate was  $< 1.0$  percent until the 2009–10 school-year, and has increased steadily each year thereafter. It remained between 1.0 and 1.9 percent until last school-year, reaching 2.1 percent, and consistent with this upward trend, reached 2.4 percent this school-year (Enclosure 4).

#### Results—Seventh Grade:

Statewide, 96.2 percent of seventh-grade students were reported as receiving all immunizations required for school entry/attendance. That is, all immunizations required for kindergarten entry, as well as one dose of tetanus-diphtheria-pertussis (Tdap) vaccine.

Sixty-one of 67 counties, or 91.0 percent, achieved or exceeded the 95 percent state goal. Statewide, 429 students, or 0.2 percent, had inadequate immunizations or inadequate documentation of immunizations. Students with exemptions from immunization accounted for 3.7 percent of the total seventh-grade population as reflected below (Enclosure 5):

- 3,699 temporary medical exemptions, or 1.6 percent
- 835 permanent medical exemptions, or 0.4 percent
- 3,671 religious exemptions, or 1.6 percent
- 300 30-Day exemptions, or 0.1 percent

Like the kindergarten population, the RE rate for seventh-grade in private schools is more than twice that of public schools, with 3.0 and 1.4 percent, respectively. Seventeen counties (25 percent) have a RE rate  $\geq 5$  percent in their private schools, compared to just one county (Columbia) (3 percent) in their public schools (Enclosures 6 and 7). The RE rate was  $< 1.0$  percent until the 2013–14 school-year; and has remained above one percent since. This is the seventh consecutive year Florida has exceeded the state goal for seventh-grade, and the thirteenth consecutive for the national goal (Enclosure 8).

Schools need to enforce the 30-Day exemption policy, as noted in *Purpose* in page one. Inadequately immunized non-transfer students should not be permitted school entry or attendance **until presenting proper documentation of vaccination for grade. It is the school's responsibility to follow up with students with temporary medical and 30-Day exemptions, ensuring students complete the immunization series.**

Collaboration between the school's health nurse and staff responsible for receiving and or tracking immunization records, is crucial. Schools using a reminder system to track those students not up-to-date with required immunizations/immunization documentation tend to have better vaccination coverage rates.
