LICENSE RENEWAL HOW-TO:

Professional Educator License (PEL) Career and Technical Educator (ELS-CTE) Chief School Business Official (ELS-CSBO)

Your Illinois educator license must be renewed and registered by August 31, 2020. You may login to your Educator Licensure Information System (ELIS) account to renew your license beginning April 1, 2020.

To renew and register your **professional educator license** or **educator license with stipulations** endorsed for a career and technical educator field or chief school business official, follow the steps below.

- 1. Login to your ELIS account (https://sec3.isbe.net/IWASNET/login.aspx).
- 2. Be sure your PD/Employment status is accurate.
