LEVY RENEWALFebruary 11th, 2025 Ballot

The Evaline School District will be seeking your support for a replacement educational programs and operations levy for two years, to replace the previous two-year levy approved in 2023.

These funds have been essential in maintaining the high standards we expect from our educational programs, from transitional kindergarten through sixth grade. While state and federal

governments continue to mandate programs, standards for equipment and facilities, and policies that increase operational costs, their funding remains insufficient to cover these expenses. As a result, we must seek continued community support through this levy to ensure the continued success of our district.

What will the renewal levy cost Taxpayers?

Proposition 1 is **not a new tax** and if passed, would replace the expiring local levy at the new annual amount of \$269,000 per year. The new estimated levy rate would be \$0.92 per \$1,000 of assessed value in 2026 and \$0.88 per \$1,000 in 2027. The previous voted rate was \$0.83 per \$1,000. This is the first request for a levy increase in 16 years.

How do we compare to neighboring districts Rates and bond rates?

Evaline's rate per \$1000 is approximately one third lower than our bordering school districts.

How much of the school district's budget comes from the levy?

About 20% of the district's budget comes from the levy.

Is there a senior tax exemption?

If you are a senior citizen or disabled person in need of property tax assistance, you may be able to take advantage of the property tax exemption program. To see if you qualify, call the Lewis County Assessor's Office at 360.740.1392 or visit their website at: www.lewiscountywa.gov.

What will the levy funds support?

The passage of Proposition 1 supports

that are not fully funded

by the State of Washington,

including, but not limited to:

- Non-high payments: Evaline does not have a middle or high school, therefore the district pays semi-annual levy fees to neighboring districts where our 7th-12th grade students attend middle and high school. Non-high payments consume approximately 20% of these levy dollars
- Class size reduction: Evaline's four classroom model ensures greater personalized learning
- Additional educational supports including Library, Counseling and Social Emotional Learning
- The annual winter play as well as other music programs and activities
- Curriculum replacement
- Technology equipment and enhancements
- Security and emergency preparedness
- Field trip fees and transportation
- Regular transportation not fully funded by basic education
- Student food services: free breakfast and lunch are served daily to ALL students
- District and student support services provided by the ESD113 and other cooperatives and school districts
- Increasing costs for infrastructure such as utilities, maintenance, operations and insurance

What's the difference between a LEVY and a BOND?

Levies = Learning

Levies pay for the learning that takes place inside schools like teaching staff, nurses, utilities and extracurricular activities.





Bonds = Building

Bonds are for new construction and rebuilding of schools.

Evaline currently does not have a bond, while most schools have bonds that extend over 20 to 30 years. Remarkably, Evaline's last bond, passed in 2011, was structured for repayment in just 6 years.



Grants = Good Stewardship

- Evaline has actively pursued grant opportunities, which do not require repayment, to reduce the financial burden on taxpayers and minimize the need for bonds.
- The new portable space now accommodates our 5th-6th grade classroom, the district office, and the boardroom. This change has not only freed up valuable space in the main building for expanded learning areas but also enhanced security by physically separating the office from the schoolhouse.
- Thanks to two State Healthy Kids Grants, we were able to add a covered play structure, along with a fantastic new "big toy" and a basketball area, enriching the outdoor play experience for our students.
- We are excited to be in line for a \$6 million building modernization grant. Stay tuned for more updates as we move forward with this exciting opportunity!
