I. General Conditions

The following are General Conditions for the equipment to be purchased as outlined in the Technical Specifications.

1. Scope of Work

Modifications to this ITB are not permitted without prior written approval from Benton County School District.

2. Pricing

All pricing must be clearly stated and must include any and all additional charges for shipping, handling, transportation, etc. Please be advised that public schools are specifically exempted from the payment of Mississippi Sales Tax.

It is the intent of Benton County School District to purchase new equipment. Bids will only be considered valid if the quoted items are in new, unused condition. Additionally, BCSD desires to purchase the latest version of the specified computer equipment.

In the case of discrepancy in computed bid pricing, the unit price shall govern and the total price shall be revised accordingly.

Bid prices shall remain valid for 120 days after the scheduled opening date.

3. Withdrawal of Bid

Requests to withdraw a bid after it has been submitted must be made in writing and received by BCSD prior to the scheduled bid award date. Bids may not be withdrawn after the scheduled award date.
