South Christian Elementary is located in a rural area at the southern end of Christian County. Although located in a rural area, our population consists of students from several areas of Christian County including Hopkinsville, Herndon, Lafayette, and Oak Grove. a military or rural background. South Christian has a current enrollment of 560 students including Pre-K through 5th Grade Students in person traditional learning. This is the first year in eight years that South Christian has not been a Pre-K through 6th Grade School. Special education students make up 22% with 10% of the 22% being students that receive Speech Services only. and South Christian has 6.8% of English Language Learners. 100% of the certified teachers have a bachelor's degree, 41% have at least one master's degree, 2% have a doctorate degree. Four teachers are National Board Certified by the Kentucky Educational Professional Standards Board. The average years of teaching experience for our staff is 12 years. Many of our students are associated with the military. Nearly half of the military families are transitional families. Our educational program is designed to meet the needs of this transitional population with extensive formative testing to track progress of each student.

South Christian uses a collaborative method to create the school's improvement plan. Administration works along side teachers to create a priority plan. Goals are developed from our work with teachers using academic data and non academic data as the driving force in addition to parent and student input. Then high leverage strategies and structures are used to prevent and close achievement gaps. The priority plan identifies timelines and all roles and responsibilities of all staff for implementing the plan. Students identified as performing less than proficient or average academically are placed in additional strategic and intensive groups to make progress. Students needing more support are assigned a staff mentor within the building or within the larger school community that can check and connect on a weekly basis to ensure students have the relationships and added support needed to be engaged in school and to learn when here at school. We also invite parents to collaborate on intervention plans designed to assist students needing the extra support. We encourage families to be active participants in their child's education. In the next 3 years, we would like to have 80% or more of our students leaving the primary grades reading on grade level and at 70% of students in Grades 3-5 performing at the proficient level or better in Reading and Mathematics. We are also striving for 80% or our daily lessons to include vibrant learning experiences and profile of a graduate competencies embedded and communicated in the learning each day. We are also striving to have 100% of teachers in our classrooms with a degree in education with no emergency certifications. Family engagement is another area of improvement for us. We have several after school events that parents participate in, however, the family engagement we would like to see are more parents assisting with study habits and school assignments at home and reiterating the value and importance of education.
