7. NEW BUSINESS

A. 2025-2026 LCAP

The Board will consider approval of the Stony Creek Joint Unified School District's 2025–2026 Local Control and Accountability Plan (LCAP). The LCAP outlines district goals, actions, and expenditures aligned with state priorities to improve student outcomes. Key focus areas include student achievement, parent engagement, school climate, and targeted support for English learners, foster youth, and low-income students. This item follows the required public hearing held to gather community feedback and input prior to final adoption.

B. 2025-2026 Budget

The Board will consider approval of the Stony Creek Joint Unified School District's proposed 2025–2026 budget. The budget outlines anticipated revenues and expenditures for the upcoming fiscal year and reflects updates based on current state funding, grant allocations, and district priorities. Key areas include enrollment projections, staffing costs, program funding, and operational needs. This action follows the required public hearing, during which the Board and community had the opportunity to review and comment on the proposed budget prior to final adoption.

C. Local Performance Indicators

As part of California's accountability system under the California School Dashboard, Stony Creek Joint Unified School District will present its annual update on the Local Performance Indicators. This presentation fulfills the state requirement to report progress in the areas of parent engagement, implementation of academic standards, local climate survey results, access to a broad course of study, and coordination of services for foster youth. The indicators will reflect the district's self-reflection tool and identify areas of strength and continuous improvement for the 2024 reporting cycle. The Board will

review the results for submission to the California Department of Education as part of the Dashboard public release.
