



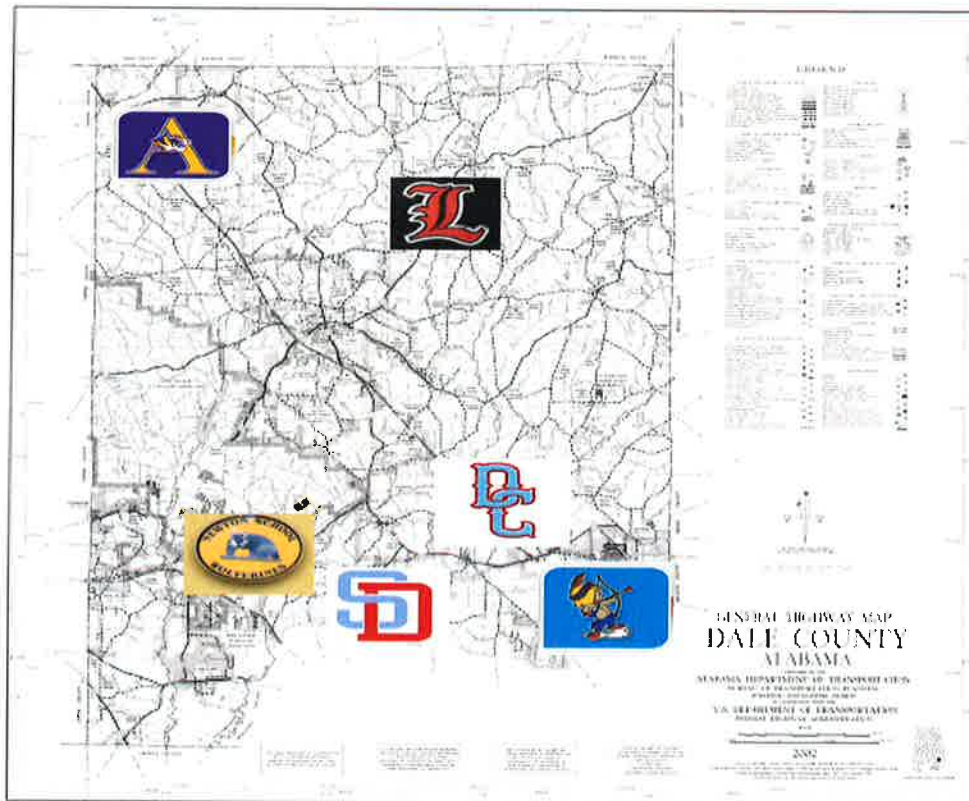

## II. Wellness

### A. Dale County Schools Monitoring and Attendance

**HOME** is the first point on the screening continuum. Students and employees that exhibit the symptoms of COVID-19 should stay at home. Families are encouraged to self-monitor symptoms of illness, which could include fever, dry cough, loss of taste/smell, sore throat, etc. Employees and students that have the symptom of loss of taste/smell or a positive COVID-19 test should self-quarantine for 10 days from the onset of COVID-19 symptoms. Unvaccinated employees and students that reside in the household with a positive COVID-19 person should self-quarantine for 10 days. Fully vaccinated employees and students and persons that have recovered in the last 90 days from COVID-19 do not have to self-quarantine if they are symptom free.

**TRANSPORTATION** is the second point on the screening continuum. Bus drivers will communicate with school administration if a student displays symptoms while traveling on a school bus. Bus drivers will place symptomatic students away from other passengers. The CDC requires the use of facial coverings in public transportation; this includes public school buses. Students and drivers are to wear facial coverings to comply with the CDC mandate. Bus drivers will have a supply of mask on-hand for students if the student were to request a facial covering. Buses will be sanitized after each use (route and extracurricular).

**SCHOOL** is the final point on the screening continuum. School staff will visually check for symptoms during the school day (which may include temperature checks) and/or confirm with families that students are COVID-19 symptom free. In the case of a positive COVID-19 test of a student or staff member; or if a student or staff member displays symptoms of COVID-19 he/she will be immediately isolated from others and arrangements will be made for the sick employee/student to be sent home. Employees and students with symptoms of COVID-19 are encouraged to seek professional medical attention before returning to school. School officials will use best practices in protecting others at school. Cleaning protocols are in place to mitigate the spread of all viruses and illnesses. COVID-19 is a reportable disease and as such falls under the Alabama Notifiable Disease laws. School nurses are required to complete all digital and hand written requirements including the Online COVID-19 Report Card and the Communicable Disease Report Card.

## **B. Healthy Habits**

**FACIAL COVERINGS** have been shown to be a good method in stopping the spread of COVID-19. Students, staff and guest are strongly encouraged to wear facial coverings. Students and employees will wear facial coverings at their own discretion. Facial coverings are required by CDC mandate on school buses.

**MAINTAINING PHYSICAL DISTANCE** between persons is another method that may reduce the risk of spreading COVID-19. Maintaining physical distance will not always be practical/possible inside school settings (including buses) and there should be no expectation to do so. However, Dale County Schools will implement best practices when possible and practical. The suggested physical distance is 6 foot between un-masked persons and 3 foot between masked persons. Individuals following these guidelines will not have to isolate/quarantine if exposed to a positive or symptomatic person.

**PROPER CLEANING AND SANITATION** are important tools to kill viruses and, thus, reduce the spread of infection. Dale County Schools will implement best practices in proper sanitization. Care will be taken to make sure the appropriate sanitizers are purchased and that custodial staff understand the proper application as well as safety precautions. Proper hand washing and/or the use of hand sanitizers is also a tool to kill viruses and remove them from the environment, thus reducing the spread of infection. Teachers will instruct children to wash hands and to apply hand sanitizers in a safe and responsible manner as we have done for decades. Dale County Schools will have a heightened awareness of the importance of these practices. Custodial and other related staff may receive professional development on proper sanitation and disinfecting procedures and products. Cleaning schedules will be modified to handle sanitation/disinfecting after COVID-19 symptomatic individuals are identified. Spaces (classrooms, libraries, offices, etc.) will be closed for deep cleaning and sanitization if a symptomatic or positive COVID-19 person is identified in the space.

**PERSONAL RESPONSIBILITY** is expected of all students and stakeholders. We all must take personal responsibility. This simply means to be responsible in your decisions – stay at home if you are sick, wash your hands often, don't touch your face, keep a distance from non-household members, wear facial coverings, sneeze and cough in a tissue or your elbow, check your temperature often, monitor members of your family/household for symptoms of COVID-19. If you have a known exposure to COVID-19 you are encouraged to self-isolate and contact your healthcare provider.

### **SYMPTOMATIC STUDENT OR STAFF MEMBER**

Students or employees that display symptoms of COVID-19 will be sent to the school nurse. The school nurse will evaluate the situation and, along with school administrators, implement best practices for isolation and disinfecting. In the case of a positive COVID-19 test of a student or staff member, school officials will use best practices in protecting others at school. School personnel will identify close contacts based on information gathered and to the best of their ability identify those they may have been exposed to a symptomatic or positive COVID-19 person. Families should monitor symptoms; students and/or employees should stay at home and self-isolate if displaying COVID-19 like symptoms. Dale County Schools may choose to honor all healthcare provider notes as for as quarantines and releases.

## **RECOMMENDATIONS FOR CLOSE CONTACTS**

- ✓ Asymptomatic vaccinated close contacts do not need to be sent home but should monitor for symptom, and isolate if symptoms develop
- ✓ Asymptomatic close contacts who have tested positive for and recovered from COVID-19 in the prior 90 days do not need to be sent home unless they develop symptoms
- ✓ Asymptomatic close contacts who meet the K-12 classroom physical distant rule (3-15 with mask and 6-15 without mask) do not need to be sent home unless they develop symptoms
- ✓ Unvaccinated individuals who are identified as close contact and do not meet the physical distance rules may be sent home.

### **III. Class Options**

#### **A. Curriculum Options**

Dale County Schools will offer a traditional learning model. Students will receive in-person instruction five days per week. Students in grades 9-12 will be offered virtual opportunities in accordance with Code of Alabama Section 16-46A-1.

### **IV. Day to Day Operations**

#### **A. School Calendar**

Teachers Begin - August 2, 2021

#### **B. Daily Schedule**

- ✓ Buses will unload as directed by school administration to prevent long term exposure; all persons entering school facilities should sanitize their hands by hand sanitizer or by traditional washing of hands with soap and water.
- ✓ Students will report to their first class assignment upon arrival to school.
- ✓ Breakfast will be delivered to the classroom or served “grab-n-go” style in the hallway/cafeteria.
- ✓ Students/employees will be allowed to bring and have bottled water for use during the school day; water fountains will be available.
- ✓ Parents are encouraged to pay for meals using our online payment system “My School Bucks”, which can be located on the Dale County School’s webpage.
- ✓ Parents are encouraged to apply for free/reduced meals online at the Dale County School’s webpage, the application is under “My School Apps” link; paper applications will be distributed.
- ✓ Physical Education, Career Tech, and other close contact classes will social distance as much as possible without disrupting the integrity of the lesson/activity.
- ✓ Playgrounds, lunchrooms, weight rooms, and other common areas will be sanitized often and to the best extent possible.
- ✓ Hand sanitizer will be readily available in classrooms, common areas, and hallways.
- ✓ When checking students out of school – only one person should enter the school and report directly to the office; the visitor should respect social distancing and conduct the check-out process as quickly as possible; the parent and child need to leave campus immediately.

#### **C. Special Events**

- ✓ Athletic events will be scheduled and regulated in accordance with guidance provided by the Alabama High School Athletic Association.
- ✓ Field trips, pep rallies, assemblies, and award ceremonies are allowed. This decision may be re-evaluated as the school year progresses.
- ✓ Club activities are allowed and encouraged, but may be re-evaluated as the school year progresses.

#### **D. Child Nutrition Program**

- ✓ Meals will be served in the school cafeteria.
- ✓ All meals will be served in accordance with USDA guidelines.
- ✓ Cafeteria tables will be sanitized between each lunch period.
- ✓ Water fountains will be available for use.
- ✓ We will serve breakfast in the classroom at each school or have a “grab-n-go” style breakfast.
- ✓ Students will eat lunch in the lunchroom.

#### **E. Attendance**

- ✓ Dale County Schools will continue to record/take attendance and enforce compulsory attendance laws for students
- ✓ COVID-19 positive students, symptomatic students, and/or quarantined students should provide the school documentation from healthcare providers of such for an excused absence
- ✓ Employees will take leave as provided by board policy; the system no longer has COVID leave

#### **F. Health Services**

- ✓ Each school nurse will provide updates from the local health department, ADPH, ALSDE, and CDC as new and evolving guidelines are issued to the Superintendent.
- ✓ The Lead Nurse will report and communicate to the Superintendent and/or Associate Superintendent on a regular basis of changes or modifications to procedures and/or guidelines; and report on symptomatic students/employees or positive COVID-19 cases.
- ✓ An additional nurse will be hired to help in critical care areas.
- ✓ A paraprofessional will be hired to support each nurse and sick students; and to help monitor isolated students/employees; and organization of health supplies.

#### **G. Technology**

- ✓ All students in grades K-12 have access to a digital device.
- ✓ All students and employees have access to Wi-Fi on campus and at on campus events.

#### **H. Human Resources and Personnel**

- ✓ Additional personnel that will be employed to support the Return to Instruction Plan
  - Literacy Specialist/Interventionist
  - Math Specialist/Interventionist
  - Additional full time Nurse
  - Paraprofessionals to support each nurse
  - Extended Day teachers
  - Intervention Teachers
  - At-Risk Aides
  - EL District Teacher
  - Intervention Aides
  - Class Size Reduction Teachers to keep class sizes as small as possible

#### **V. Transportation**

Social distancing on a school bus is not practical. Dale County Schools will implement best practices to try and prevent the spread of COVID-19. Best practices like assigned seats, loading back to front, unloading front to back, wearing facial coverings, and safe bus behaviors may be implemented to promote health and safety. CDC guidelines for public transportation require the use of facial coverings on school buses. Bus drivers will have facial coverings available upon request by students/parents.
