7. Superintendent’s Report

Superintendent Nehrmeyer updated the Board on special programs and events including our 23rd annual Science Fair, our GATE Parent Showcase, Fueling the Future grocery distribution coming up on December 16th, SaddleBrooke Community Outreach sponsoring 30+ families for Thanksgiving, a \$6,000 grant written by Shannon Soulé to provide warm

clothing for kiddos from the San Manuel Elks Lodge, and Debbie Quick's success with Donor's Choose projects and the new flight simulator she received.

8. Discussion and Approval of the District's calendar for the 26/27 school year.

Superintendent Nehrmeyer presented to the Governing Board the District Calendar for the 26/27 School Year.

Mrs. Taylor moved to approve the calendar as presented, and Mr. Borland seconded approval, all in favor, motion carried.

9. Discussion and possible action regarding the use of proceeds from the sale of Oracle Ridge property.

Superintendent Nehrmeyer presented to the Governing Board and provided a summary of last month's special meeting for the community on the three options for the use of the Oracle Ridge sale proceeds. She then presented the District's recommendation to allocate the proceeds toward campus capital improvements, including:

- Installing new tile in the Preschool and new carpet in Grades K-4
- Renovating the restrooms in the Cafeteria and Gymnasium
- Replacing the 20+ year-old HVAC units on Building A (School Office, Special Education, Cougar Math)
- Replacing the Gym lighting and flooring
- Completing missing sections of security fencing around the campus perimeter

The Governing Board voted to use the Oracle Ridge Proceeds on Capital Improvements on the Mt. Vista K-8 School campus.

3 Ayes, 1 Nay. Motion carried to approve the use of the proceeds from Oracle Ridge Sale for the specific Capital Improvements listed at Mt. Vista K-8 School.
