

INTERDISTRICT COOPERATIVE AGREEMENT FOR GIRLS SOCCER PROGRAM
Between Clatskanie, Rainier, and Knappa School Districts
2025–2026 School Year

This Interdistrict Cooperative Agreement (“Agreement”) is entered into between **Clatskanie School District**, **Rainier School District**, and **Knappa School District**, collectively referred to as the “Districts,” to establish and support a cooperative girls soccer program for the 2025–2026 school year.

1. Purpose

The purpose of this Agreement is to provide access to an interscholastic girls soccer program for students from Clatskanie, Rainier, and Knappa High Schools through a cooperative arrangement, while establishing clear responsibilities for each participating district.

2. Practice and Game Locations

- Practices will take place at Clatskanie City Park.
 - Games will be hosted at both Clatskanie and Rainier facilities according to a mutually agreed-upon schedule.

3. Transportation and Travel Logistics

- Rainier School District will provide the bus transportation to games.
- The team bus will depart from Rainier High School’s "Airlock" area.
- Clatskanie and Knappa students will be transported by Clatskanie School District from the CMHS back parking lot to the Rainier bus departure location.
- If feasible based on the game location, the Rainier bus may pick up Clatskanie and Knappa students directly at the front of CMHS and/or Knappa High School (KHS).
- Parents/guardians of Clatskanie, Knappa, and Rainier students are responsible for transportation to and from practices at Clatskanie City Park.

- If the game-day route passes by KHS, students will be picked up at the school. If it does not, families must transport students to CMHS prior to bus departure.

4. Financial Responsibilities

Rainier School District will be financially responsible for the girls soccer program, including:

- Coaching salary
- Supplies and uniforms
- Officials
- Transportation for practices and games

There will be no financial obligation for Knappa School District beyond contributing collected user fees from Knappa students.

- Knappa will collect athletic user fees for its students and submit these funds to Rainier School District to help offset program costs.

Clatskanie School District will be financially responsible for:

- Transportation of Clatskanie and Knappa students from CMHS to Rainier for games.
- Clatskanie families will pay user fees directly to Clatskanie School District, which will transfer those fees to Rainier School District athletics.

All ASB fundraising or expenditures related to girls soccer must comply with ASB financial laws, and all three districts will work to ensure equitable access and opportunity for participating students.

5. Supervision and Event Management

- **Clatskanie School District** will provide athletic supervision and manage events for home games hosted at CMHS facilities.
- **Rainier School District** will do the same for home games hosted at their facilities.

6. School of Record and OSAA Requirements

- **Rainier School District** shall serve as the **school of record** with the Oregon School Activities Association (OSAA).
- Rainier will be responsible for:
 - Roster and schedule entry and maintenance on the OSAA website
 - Game score reporting
 - All official OSAA correspondence

7. Eligibility, Registration, and Monitoring

- Each district is responsible for maintaining:
 - Registration and enrollment
 - Academic progress
 - Attendance tracking
 - User fee collection for their own students
- Each district shall report potential eligibility concerns to **Rainier**, the school of record.

8. Term and Termination

- This agreement is effective for the **2025–2026 school year**.
- Any district may withdraw from the agreement with **30 days written notice** to the other parties.
- All financial obligations incurred prior to termination must be fulfilled unless otherwise agreed upon in writing.
