## **Bid Specifications**

**This project will be funded under provisions of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA). Certain mandatory federal requirements apply to this solicitation and will be made a part of any contract awarded, including but not limited to: (a) Davis Bacon Act (DOL Regulation 29 CFR Part 5), (b) Suspension and Debarment (Executive order 12549 and 12689, 2 CFR part 180), (c) Contracting with small and minority business enterprise and labor surplus area firms, 2 CFR §200.321, (d) Domestic Preferences for Procurements, 2 CFR §200.322, (e) affirmative action to ensure Equal Employment Opportunity (Executive order 11246 as amended by Executive order 11375 and DOL Regulation 41 CFR Part 60).**

**Location: Franklin County High School (Section 1)**

### **Scope of Work (includes all materials and labor)**

- **Remove two (2) sets of 7'x10' exterior doors and frames**
- **Add wood stud framing to each of the voided areas**
- **Add 7/16" exterior wall sheeting**
- **Add R-13 fiberglass batt wall insulation**
- **Supply and install estimated ½" bc plywood for interior wall finish with 1x4 trim**
- **Supply and install estimated 1,080 modular face brick with all necessary mortar and sand**
- **Apply water proofer to face of masonry units**
- **Cut, break, and partially remove 120 square feet of existing concrete steps and retaining walls**
- **Remove all demolished concrete to off-site location**
- **Cut, break, and demolish 3'x10' concrete canopy (structural steel modifications as needed to remove)**
- **Masonry repair as needed for original canopy area**
- **Backfill and compact original stairwell as needed**
- **Add topsoil to create a slope against the brick wall to help direct surface water away from building**
- **Add sod to prevent erosion to selected areas of construction**
- **Paint immediately affected interior wall sheeting and new trim**

- **Pour an estimated 6'x22'x4" concrete sidewalk cap over the retaining walls for the construction area located outside the south side of the building**
- **Dispose all construction debris**

## **Section 2**

- **Remove one (1) set of 7'x10' exterior doors and frames**
- **Remove exterior wall sheeting and framing**
- **Add 2x4 framing to support an elevated 42" wide x 7' tall hollow-metal jamb door with ½ glass**
- **Add 7/16" exterior wall sheeting**
- **Add R-13 fiberglass batt wall insulation**
- **Supply and install estimated ½" bc plywood for interior wall finish with 1x4 trim**
- **Additional interior modifications include removing and replacing one (1) interior door with inswing capabilities**
- **Supply and install 42" exterior door with hardware**
- **Form and pour an estimated 5'x14' ADA grade ramp w/landing for exterior of building**
- **Fabricate and install ADA compliant 1-1/4" schedule 40 pipe rail for outer edge of ramp and landing**
- **Supply and install masonry material and labor for an estimated 9'x10' area of exterior wall**
- **Construct a 10' interior concrete ramp with natural grey finish**
- **Add topsoil to create a slope against the brick wall to help direct surface water away from building**
- **Add sod to prevent erosion to selected areas of construction**
- **Paint immediately affected interior wall sheeting and new trim**
- **Dispose all construction debris**
