2. Discussion regarding breakfast and lunch deliveries with Board recommendation and possible decision

Ms. Barbara Shields, Food Services Director, explained to the Board members that with the opening of the Park and with Spring break, the line to get even to the bypass lane of the park entrance is adding one to two hours to the daily food transportation times. She noted the following:

- We started the school year with three routes. The Supai Camp route was dropped on 3/22/21 since those students are now on-campus, bringing us to two daily routes.
- Before school opening on 3/22/21, the Tusayan route had 26-28 meals. Since opening for in-person instruction, the number is between six and fifteen. For the Valle route, the number has been no more than ten recently, and generally, only between two and ten maximum meal deliveries daily.
- We are scheduled to deliver six packets to Tusayan, however recently only one was picked up. For Valle, we prepare four packets and only two have been picked up.
- We have looked at once a week or twice a week food delivery options, but there are logistics problems, most notably refrigeration issues.
- The Governor's Executive Orders require we provide meals, but not that we deliver them.
- Pickup is sporadic, not the same families each day.

Ms. Shields recommended that, at this time, we should shift focus to on-campus students, continue to provide meals on a pickup basis, but cease delivery of meals.
