### SNP ANNUAL APPLICATION

## IT'S TIME!



The School Nutrition Programs (SNP) application for School Year 2024-25 is available in the Web-Based Illinois Nutrition System (WINS). **Sponsors should complete the application by June 30, 2024.** 

The application is an annual requirement for all sponsors to participate in such programs as the National School Lunch Program (NSLP), School Breakfast Program (SBP), After School Snack Program, Special Milk Program, and Illinois Free Lunch and Illinois Breakfast. Please note that if you are participating in the Community Eligibility Provision (CEP), this annual application is still necessary to finalize participation plans in the meal programs for the upcoming school year.

**UPDATING CONTACTS:** As part of the annual application, you will be asked to update contact information in WINS. It is not a best practice to make one district personnel the contact for all areas of the School Nutrition Programs. Most contacts can be edited by the district in WINS without assistance or approvals. Look for the pencil icon

to edit. Please note that the Food Service Director should be a district employee responsible for the day-to-day operations of the meal program. It cannot be a food service management company employee. We also want to remind you that a change to the Authorized Representative/District Superintendent must be made in the Entity Profile System (EPS) so all agency systems can reflect the change.

May is a good month to remind
sponsors of this program outreach
requirement.

Another way to meet the Summer Meals outreach requirement would be to include text on menus and the district website. Sample language is:

FREE SUMMER MEALS: To find a Summer Meals site near you, call (800) 359-2163, text FoodIL to 304-304, or view the USDA online map at <a href="https://www.fns.usda.gov/meals4kids">https://www.fns.usda.gov/meals4kids</a>.

Sponsors will want to document their



outreach each school year. In the event of an Administrative Review, this documentation will be requested.

You may hear the Summer Meal program called SUN Meals, which is the traditional in-person congregate/ group meals and snacks provided at sites in communities with high rates of poverty. The U.S. Department of Agriculture has <u>launched new branding</u>, which sponsors can use to create their own promotional materials.

SUN Meals is part of the SUN Programs: USDA's Summer Nutrition Programs for Kids. It also includes SUN Meals To-Go (meal service is available in some rural communities for pick-up or home delivery), as well as SUN Bucks, which is a grocery electronic benefit transfer program for families with eligible school-aged children; this is known as Summer EBT. ### **Diversion to Processor Pound Sweep**

For those schools that diverted pounds to processors during School Year 2023-2024, please use all pounds by June 30, 2024. Pounds remaining in school accounts on June 30, 2024, will be swept to the State of Illinois account.

Please check <u>ProcessorLink</u> and <u>K12</u> to review your pound balances, and determine how you can use the pounds prior to June 30. Illinois' full sweep procedure is available in

the <u>School Nutrition Programs Administrative Handbook</u> (Page O-9).

Please do not view the sweep as punitive, but rather efficient management of funds. The state will gladly provide available state account pounds to any school district that can use them.

# **Upcoming SNP Trainings**

The Illinois State Board of Education Nutrition Department is planning multiple training options in 2024-25 to replace our annual School Nutrition Programs Back to School Conference, which has been held in late July in recent years. These will include both in-person and virtual trainings to provide flexibility for schools for important trainings and professional development opportunities.

We are working with the University of Illinois Extension on the ABCs of School Nutrition initiative to present in-person regional trainings for School Nutrition Professionals on various topics across the state. Registration just opened for several locations at <a href="https://schoolnutrition.extension.illinois.edu/events">https://schoolnutrition.extension.illinois.edu/events</a>. More cities will be added soon.

We are also planning a mix of virtual and in-person trainings on Direct Certification, Household Eligibility Applications, Verification, Local Wellness Policies, and are in the early stages of partnering with other agency departments to present an ISBE Wellness Conference next year. In addition, the U.S. Department of Agriculture just released updates to the School Nutrition Standards this week. We are reviewing and will be developing trainings. We highly recommend signing up for the USDA's webinar on the final rule, which is set for 1 p.m. May 9. Registration is under way; click here to sign up.
