

SOLE SOURCE CERTIFICATION

(This form must be certified completely by the Purchasing Director prior to purchase)

All Sole Source Purchases must have had a Declaration of Intent to Procure posted on the County's website by the Purchasing Department at least 30 days prior to procurement. Following the 30 day publication, if no other vendors have come forth disputing the Sole Source and as long as there are no un-resolved protests pending, then the item or service may be purchased once a Sole Source Certification Form is completely executed.

A Sole Source Certification is required when there is only one vendor in the state or overall geographical region that can provide an item or services. For example, if the sole source is located in Roswell, an attempt must be made to contact vendors in Roswell and surrounding areas which may have the item. However, if the sole source is located in Texas, then an attempt must be made to contact vendors in the Texas and New Mexico region. A written response from contacted vendors stating they do not offer the product or service required shall be obtained and provided to the Purchasing Director (emails are acceptable).

If there is a GSA or State Contract for the item, a sole source certification is not permissible.

If another vendor which has the same item or services needed has been contacted, a Sole Source Certification is not permissible.
