Child Study Team Agreement 2021-2022

The rescinding of the motion made at the June 21, 2021 board meeting, approving Salem County Special Services for Child Study Team and Speech Services for the 2021-22 school year.

Further, the approval to enter into an agreement with the Quinton Township Board of Education to provide Child Study Team and Speech Services for the 2021-2022 school year effective September 1, 2021 through June 30, 2022 at a cost of \$31,500. This contract with Quinton replaces the contract with Salem County Special Services, and represents significant cost savings to Elsinboro.

Copier Lease

The contract with Ricoh, USA for leasing the following copiers under State Contract # A40467-CPC:

- 1. MP5055SPG Teacher's Work Room Copier
- 2. MP3555SPG Main Office Copier

This is a 48 month lease, and replaces the current copier lease that expires at the end of August, 2021. The cost for this lease is \$388.42/month, which covers all service, parts, labor and supplies (except paper) for both copiers and includes up to 27,500 copies per month, with overages of \$.0072/copy. This is the same lease that we currently have in place, and at the same cost.

OOD Placement - Lower Alloways Creek

The Special Education Tuition Contract between the Lower Alloways Creek Board of Education and the Elsinboro Township Board of Education for the out-of-district placement of one student (SID #2425960153) residing in Elsinboro Township to attend the Special Education Program at the Lower Alloways Creek School for the 2021-2022 school year, at a yearly tuition rate of \$19,300.

OOD Transportation - Jointure with LAC Board of Education

The renewing the transportation jointure with Lower Alloways Creek Board of Education for the 2021-22 school year at a rate of \$40/day or \$7,200 per year. This agreement is for the transportation of 1 Elsinboro resident student to/from LAC School from/to home on LAC Route EL5. Elsinboro will only be billed for in-person days for this student.

Transfer to Capital Reserve Funds

The rescinding of resolution # 2021-3, from the November 16, 2020 board meeting. By rescinding this motion, the board approves the transfer of \$107,425 from General Fund back to the Capital Reserve Fund, as of 6/30/21. The transfer from Capital Reserve to General Fund was board approved on November 16, 2020. This transfer was for the purchase of an emergency generator. However, the purchase order was cancelled effective June 30, 2021, and reissued on July 1, 2021. The generator will now be paid with funds from Cares III and the Security Grant. Therefore, the unused funds must be transferred back to the Capital Reserve Fund.
