Principals' Reports

Elementary

Ms. Postl provided an update on the elementary. The results from the 3rd grade ELA fall testing showed 66% of students scored proficient or better. This is an increase from last year's score of 61%. She also informed the

Middle School

Mr. Storrer provided an update on the middle school. 6th grade students welcomed guest speakers Cole Plassman from Fulton County Soil and Water and Molly Hunt from Ohio Geology. They shared their expertise about soil and rocks. Mr. Storrer also thanked and recognized the Napoleon Eagles for their donation of \$5,000.00 towards the 6th grade Camp Willson trip in May 2026. Lastly, Mr. Storrer recognized the students of the month: Dawsyn Rogers, Jesse Brink, Lorelei Gombash, and Addi Westhoven.

High School

Mr. Radwan provided an update on academics, the arts, and athletics in the high school. He highlighted the Leadership Class Stuff the Bus Food Drive. A bus is currently parked by the football stadium where community members can drop off donations of items. They are also having a competition to see which grade can donate the most items. Mr. Radwan also noted the Preparing of the Jungle event last month was a success. Freshmen students took the YouScience Aptitude Test, participated in exploration labs, listened to an AI presentation from a BGSU professor, and heard career stories from local community members. Sophomore students took the geometry and biology readiness tests, participated in exploration labs, listened to an AI presentation from a BGSU professor, and heard career stories from local community members. Juniors took a practice ACT test, listened to an AI presentation from a BGSU professor, and heard career stories from local community members. Seniors had the opportunity to choose between job shadowing someone new, visiting a college, or touring local businesses.

Mr. Radwan congratulated and thanked the marching band for their extended season. They did a nice job representing the school. Mr. Radwan also announced this year's musical: 'Legally Blonde: The Musical.'

Lastly, Mr. Radwan congratulated the football team for winning the Division V State Championship. He also wished all of the winter sports teams the best of luck as they begin their season.

Athletic Report

Mr. Pohlman reported that winter sports schedules will be finalized soon.

Superintendent's Report

Mr. Peters congratulated all the fall athletes for their success this year. He also commended Athletic Director Kaleb Pohlman for all his behind the scenes work in the athletic department.

Mr. Peters recognized outgoing Board Members Mr. John Weaver and Mrs. Andi Zacharias. John has served on the board for 12 years and Andi has served for 8 years. Mr. Peters thanked them for their dedication to the students of Liberty Center. Mr. Weaver recognized the involvement of everyone in the district, noting the district remains in good hands. Mrs. Zacharias noted how proud she is to have served on the board and that the district continues to head in a positive direction.

Mr. Peters provided information on the 2026-27 school year calendar that is on the agenda for approval. With the Henry County Fair scheduled for August 13-20, 2026, the goal was to start after the completion of the fair.

The calendar was decided upon based on input from staff and the unions. The quarters end October 23rd, January 8th, March 19th, and May 27th. The 2027 graduation will be held on May 23rd.

Mr. Peters also provided information on the purchase of a new school bus, which is on the agenda for board approval. The bus will be purchased from Cardinal Bus Sales and Service through the META Solutions Vehicle Bids program. The cost of the new bus is \$133,959.00. The new bus will replace an existing route bus that has accumulated high mileage. It will be the district's first gas bus as opposed to a diesel bus. A gas bus is cheaper up front and other districts have noted long-term savings on them as well.

Mr. Peters noted that in recent years, the district was able to purchase two new buses, which were partially paid for with grant funds. This started the discussion of a fleet rotation schedule. Buses are monitored and serviced to ensure the longest life possible. He also informed the Board the price for buses has continued to increase, but the co-op guarantees the lowest price available.


