2022-23 Phase Three: Comprehensive School Improvement Plan

Rationale

School improvement efforts are a collaborative process involving multiple stakeholders. During the improvement planning process, leaders focus on priority needs, funding, and closing achievement gaps between identified subgroups of students. When implemented with fidelity, the Comprehensive School Improvement Plan (CSIP) cultivates an environment that promotes student growth and achievement.

Finally, a focus will be on KCWP 4: Review, Analyze and Apply Data through the PDSA model in PLCs.

In 22-23, MLK will continue with 21-22 objectives that focus on increasing proficient and distinguished scores in reading, math, science, social studies, and writing. We will continue to monitor and track students in our Gap group consisting of special needs students and African Americans. levels on the ACCESS assessment and work to increase our Quality of School Climate and Safety scores.

Operational Definitions

Goal: Long-term three- to five-year targets based on the five (5) required school level goals.
