2. Superintendent Report

- HS Student Council Presentation Madison Morales Student Council President shared with the Board how much school spirit has significantly increased this year, she also shared the upcoming events the council will work on. Ms. Delany Sanchez is the Student Council Sponsor.
- School/Student data Three years of proficiency data show continued growth in ELA, Math, and Science. Compared to surrounding districts, HVPS is on par with the state in ELA at 43%. While Math scores are not yet where we want them to be, they are steadily increasing, and overall improvement trends remain positive.

- Principals from each site shared the strategies they have implemented and the actions they will continue to take to maintain and build on these gains. They emphasized the hard work and dedication of teachers and support staff, as well as the invaluable support from parents, other school sites, and the Superintendent.
- LESC Report (Legislative Education Study Committee) and Legislative Finance Committee are two big committees that have a big impact on schools. One major concern is the high turnover rate of superintendents. The lifespan of a superintendent is anywhere from 2 to 3 years. When you talk about improvements of school we know from research, it takes at least 3 years, but more like 5 to 7 years for change to really take hold. So one of the things that the legislature did last year is pass Senate Bill 137, which limits a local school board's ability to terminate a superintendent without cause immediately following an election, when most superintendents usually get replaced. The districts need stability at the superintendent level to make a difference. In October this was brought to the LESC attention, along with other concerns.

 Project Report - MS Green House project is being worked on, should be done by Spring; the large animal facility at the VET clinic has been been on hold because of paperwork; the VET clinic has also started a small grooming facility, they have appointments all the way through January; transportation portable is in place but still working on water lines and electric lines; the field house is complete and beautiful

Superintendent Chavez expressed his gratitude to the community for approving the bond — this will bring in additional funding to support ongoing and future projects.

Garfield Elementary School (GES) hosted an AG Day, and it was a great success. Special recognition goes to Emilio Garay, a former HVPS student, who served as "Chef for the Day."
