The Governing Board of the Tanque Verde Unified School District #13, Pima County, Tucson, Arizona held a Study Session Board meeting on March 24, 2016 in the Board Room, at the Tanque Verde Unified School District Administrative Office, 2300 N. Tanque Verde Loop Rd., Tucson, Arizona 85749. The meeting was called to order at 6.59 p.m.

2. APPROVAL OF AGENDA

MOTION: Mr. Auslander made a motion to approve the agenda. Mr. Neff seconded; the motion carried unanimously.

MOTION: Mr. Auslander made a motion to approve the Consent Agenda. Mr. Neff seconded; the motion carried unanimously.

5. INFORMATION AND DISCUSSION ITEMS

A. Wolf Project – Ms. Geneasa Varner 4th grade teacher at TVES

TVES teachers Ms. Geneasa Varner and Ms. Ashley Brock were in attendance supporting the Wolf Project student presenters: Owen Brock, Sarah Herron and Robbey Skaggs. The presentation started with a short video. The students featured in the video include Garrett Thompson and Grace Adair discussing the Wolf Project, and all the different components involved with the project. As part of the Wolf project, students had the opportunity to interview a Ranger from Yellowstone park, students became involved in a video game, Wolf Quest – which taught students about Wolf behavior, how they join a pack, how to choose a mate and how to protect their territory. Each of the students Owen Brock, Sarah Herron and Robbey Skaggs spoke to the Board about this project, all expressed how much they learned and appreciated the different learning opportunities in this project which made this an interesting and fun project.

B. Dirt Road Alternate Routes - Mr. Adam Hamm

Mr. Hamm updated Board Members on dirt road alternate routes. There is one remaining dirt road we are traveling to pick up students. There are four (4) students on the Cordorniz

route. In the morning two (2) buses travel this road and in the afternoon, there are two (2) buses traveling this road, a total of 4 different buses. Mr. Hamm will work with Ms. Amy Lindflott in developing a communication to the parents advising them we will continue to transport their students; however, our pick up and drop off locations will change to either Speedway or Broadway starting the 2016-17 school year.

C. Consider Superintendent Committees – Ms. Kimberly Sharp
Preschool Financing and Building Committee and Tanque Verde Preschool Community
Connection Committee The Governing Board discussed these committees at length. Dr.
Livingston volunteered to serve on the Preschool Financing and Building Committee which
will be a smaller focused effort, looking at different structures and exploring finance options.
Mr. Adam Hamm will lead this committee. Ms. Fry volunteered to serve on the Tanque
Verde Preschool Community Connection Committee consisting of a cross section of
participants. This committee will be larger, 20 to 25 people with defined outcomes for each
meeting (probably three) analyzing trends and projections, developing timelines, learning
about community perceptions, asking, Why should we do this, and conversely asking, Why
shouldn't we do this. Ms. Claire Place will lead this committee. Both of these committees will
report their findings in July.

Board Members discussed this policy at length and requested additional time to study this policy and regulation. The motion carried unanimously. Motion: Ms. Fry made a motion to adopt KDB-R as submitted. Mr. Ruiz seconded. Board Members discussed this regulation, there was discussion regarding the word 'shall' verses 'may'. Board Members prefer the word 'shall' as reflected in the regulation. The

Assistant Principal - Tanque Verde Elementary School

Mrs. Sharp addressed the Governing Board stating under policy, GCA Professional Staff positions are created only with the approval of the Board. Ms. Sharp presented the job descriptions with the specific qualifications and performance responsibilities for both positions.

Ms. Sharp spoke about Tanque Verde Elementary School being our largest school. The 6th grade alone has a population that is nearly the equivalent to a 1/3 of the entire EGJH student population. TVES has the most students and employees. There is a need for infrastructure to support the students and employees. The addition of an Assistant Principal at this site will help support these needs.

Ms. Sharp talked about the transition from Human Resources Director to Superintendent, leaving the district without a full time HR director. In her current position as Superintendent a considerable amount of her time includes HR director responsibilities. The addition of an Assistant Superintendent would oversee Human Resources as well as

oversight among the gaps in positions of professional development and curriculum. When Ms. Glennon took on the Special Education director position, it was quickly realized her attention was needed full time in this area.

<u>MOTION:</u> Mr. Ruiz made a motion to approve Administrative positions: Assistant Superintendent and an Assistant Principal at TVES. Mr. Auslander seconded the motion carried unanimously.
