

GATEWAY, PARTNERS OPEN DOORS TO VILLAGE OF HOPE TRANSITIONAL HOUSING

In November, Gateway Community Action Partnership, The Kintock Group, and the Reentry Coalition of New Jersey held a ribbon-cutting ceremony for Village of Hope, a new transitional housing facility adjacent to Kintock in Bridgeton. The site is made up of six 100-square-foot tiny houses and a community room, and was developed for individuals as they transition out of the criminal justice system. Individuals who participate in the program can stay in these units for up to six months as they receive reentry services such as assistance with employment, budgeting, referrals to health and social services, and help finding permanent housing.

"Homelessness is something that exists not only in the Great City of Bridgeton, but in municipalities across New Jersey and America," said Albert B. Kelly, CCAP, President and CEO of Gateway Community Action Partnership and Mayor of Bridgeton. "We view the Village of Hope as an exciting and innovative pilot program here to help those reentering society have a safe place to call home. But it doesn't end there. We will work with these individuals to assist them in finding work, permanent housing and other help they may need."

The event included tours of the housing units, as well as a lineup of speakers who were indispensable for the project's success. Speakers included: Albert B. Kelly, Mayor of the City of Bridgeton, and President/CEO of Gateway Community Action Partnership; Edward Durr, New Jersey State Senator; Rev. Doctor Robin Weinstein, Pastor of Bethany Grace Community Church and Gateway Board Member; Paul Taggines, Chief Operating Officer of The Kintock Group; Kevin McHugh, Executive Director of the Reentry Coalition of New Jersey; and David Wolfsgruber, Executive Director of the New Jersey State Parole Board.
