**Meeting Minutes 8/24/2017**

The Governing Board of the Tanque Verde Unified School District #13, Pima County, Tucson, Arizona held a regular Board meeting on August 24, 2017 in the Board Room, at Tanque Verde School District Administrative Office, 2300 N. Tanque Verde Loop Rd, Tucson, Arizona 85749. The meeting was called to order at 6:58 p.m.

Mr. Ruiz welcomed Boy Scout Troop #186 and asked if they would please lead us in the pledge of allegiance.

Mr. Carlos Ruiz welcomed Tanque Verde High School Students Taylor Nye and Kaitlyn McWilliams. They will serve as Student Board Members for the 2017-18 school year; each serving a semester in this position.

**2. APPROVAL OF AGENDA**

**MOTION:** Mr. Neff made a motion to approve the agenda. Mr. Schalk seconded; the motion carried unanimously.

**3. CONSENT AGENDA** *(see attached personnel report)*

**MOTION:** Mr. Neff made a motion to approve the Consent Agenda. Mr. Fry seconded; the motion carried unanimously.

**4. INFORMATION AND DISCUSSION ITEMS**

A. Ms. Sherri Rosalik, Principal at Agua Caliente Elementary School and Ms. Kim Hubbard, Principal at Tanque Verde Elementary School had a presentation of their Summer Slide Programs.

Ms. Rosalik explained that summer programs were initially started by Ms. Barbara Drummond who introduced Coding to the students. The summer program has expanded to include Reading and Keyboarding. Students tracked their achievements in each category.

Ms. Hubbard indicated this year was the first year for TVES to become involved in the summer programs. TVES students also tracked their achievements in each category.

Board members congratulated the students for all of their achievements and principals, Ms. Rosalik and Ms. Hubbard for their efforts. The Board took a small break and spoke with students and parents in attendance and enjoyed light refreshments.

**B. Class Size / School Capacity – Dr. Scott Hagerman**

Dr. Hagerman presented his report. He indicated he and the Admin team have just begun the process of looking at Class size and Capacity. As information is gathered, several things will need to be considered:

- What is our K-12 capacity?

- What is our current guidance on class size?
- Overview of the Open Enrollment process and timeline
- Kindergarten projections
- Transitions 6<sup>th</sup> grade – 7<sup>th</sup> grade and 8<sup>th</sup> grade to 9<sup>th</sup> grade
- 11<sup>th</sup> and 12<sup>th</sup> grade Open Enrollment considerations

Next steps:

- Historical analysis
- Set up exit data collection process
- High School Schedule – (establish a working group to include staff, parents and students)

Dr. Hagerman concluded, after a thorough analysis, a master plan will be developed and presented for Board consideration.

### C. **Behavior Matrix** – Dr. Scott Hagerman

Dr. Hagerman provided the reasons for a Behavior Matrix:

- A Behavior Matrix provides expectations and consequences for student behavior
- A Behavior Matrix provides consistency across the District

There summarized the typical elements to consider:

- The issue
- The level of offence
- Required actions (law enforcement)
- Possible actions

Considerations:

1. Balance
2. Structure
  - a. Point System
  - b. Levels
  - c. First occurrence / Continued occurrence
3. Two systems or one? K-6, 7-12 or K-12

Next Steps:

- Work with the Admin and Site Councils
- Seek Legal feedback
- Bring a draft back to the Board – October or November

## 5. **ACTION ITEMS**

### **A. Policy GCCA – Professional / Support Staff Sick Leave** – Dr. Scott Hagerman

Dr. Hagerman introduced this policy. The changes he is recommending relate to notification. For an employee to qualify to receive compensation based on accrued and unused sick leave, the employee must notify the District by January 15 if they intend to terminate employment with the District. The reason for the change is to allow the District to budget more accurately, and to begin the recruiting process much earlier.

**MOTION:** Mr. Neff made a motion to adopt policy GCCA – Professional / Support Staff Sick Leave as submitted. Ms. Fry seconded; the motion carried unanimously.

**B. Policy Advisory:****BBBA – Board Member Qualifications – Mr. Ruiz**

The ASBA Advisory is adding language - *including a person who directly provides certificated or support services to the District as an employee of a third-party contractor.*

The addition of this language reflects the new language in statute A.R.S. 15-421. Therefore, the recommendation is to adopt policy BBBA as submitted.

**MOTION:** Mr. Ruiz made a motion to adopt policy BBBA – Board Member Qualifications as submitted. Mr. Schalk seconded; the motion carried unanimously.

**EEAEA – Bus Driver Requirements, Training, and Responsibilities – Mr. Ruiz**

The ASBA Advisory is adding language – *Bus drivers shall submit an Identity Verified Fingerprint Card as described in A.R.S. 15-106 that the Department of Public Safety shall use to process the fingerprint clearance card as outlined in A.R.S. 15-106. A person who is issued a school bus driver certificate shall maintain a valid Identity Verified Fingerprint Clearance Card for the duration of any school bus driver certification period.*

The addition of this language reflects the new language in statute referenced. Therefore, the recommendation is to adopt EEAEA as submitted.

Questions were raised about the costs associated with fingerprinting.

**MOTION:** Mr. Ruiz made a motion to adopt policy EEAEA – Bus Driver Requirements, Training and Responsibilities as submitted. Mr. Neff seconded; the motion carried unanimously.

**GCQF – Discipline, Suspension, and Dismissal of Professional Staff Members – Mr. Neff**

The ASBA Advisory is adding a new section *Teachers Working Under a Short-Term Certification* and language with the advisory – *A teacher who holds a teaching intern certificate, an emergency teaching certificate or another type of nonstandard certificate, that is valid for one (1) year or less, may be dismissed by the Board effective ten (10) days after delivery of the notice of dismissal to the teacher without complying with the requirements of A.R.S. conditions found in 15-537, or 15-541. Notice of the Board’s authority to dismiss pursuant to this shall be included in each teacher’s contract.*

The addition of a new language in statute referenced above prompted the addition of this language. Therefore, the recommendation is to adopt GCQF as presented.

**MOTION:** Mr. Neff made a motion to adopt policy GCQF – Discipline, Suspension, and Dismissal of Professional Staff Members as submitted. Ms. Fry seconded; the motion carried unanimously.

**GDFa– Support Qualifications and Requirements (Fingerprinting Requirements) –Mr. Neff**

The ASBA Advisory is adding a new section in this policy; *School Bus Drivers* and language with the advisory - *An applicant shall submit an Identity Verified Fingerprint Card as described in A.R.S. 15-106 that the Department of Public Safety shall use to process the fingerprint clearance card as outlined in A.R.S. 15-106. A person who is issued a school bus driver certificate shall maintain a valid Identity Verified Fingerprint Clearance Card for the duration of any school bus driver certification period.*

The ASBA language reflects the new language in statute as referenced above. My recommendation is to adopt GEFA as submitted.

**MOTION:** Ms. Fry made a motion to adopt policy GDFA – Support Qualifications and Requirements (Fingerprinting Requirements) as submitted. Mr. Schalk seconded; the motion carried unanimously.

**IJJ – Textbook / Supplementary Materials Selection and Adoption – Mr. Ruiz**

The ASBA Advisory is adding the following language: *Textbooks for high schools recommended by textbook selection committees will be placed on display in the District office for a period of at least sixty (60) days prior to the meeting at which the Board will consider their adoption. Information related to high school textbooks, which are proposed for approval, shall be placed on the District website.*

The addition of ASBA language reflects the new language in statute A.R.S. 15-102 and 15-722; therefore, the recommendation is to adopt IJJ as submitted.

This policy relates only to the high school.

**MOTION:** Mr. Neff made a motion to adopt policy IJJ - Textbook / Supplementary Materials Selection and Adoption as submitted. Mr. Ruiz seconded; the motion carried unanimously.

**JFAA – Admission of Resident Students – Dr. Hagerman**

The ASBA Advisory is adding language – *A student whose parent is transferred to or is pending transfer to a military installation within this state while on active military duty pursuant to an official military order.*

The ASBA language is based on language in HB 2107 which allows military families to begin the enrollment process prior to physical arrival in the state – it expands the definition of resident students relating to military families. My recommendation is to adopt JFAA as submitted.

There were questions and a brief discussion regarding this policy. Clarification was provided - this policy is specific to State Residency, not District Residency.

**MOTION:** Mr. Neff made a motion to adopt policy JFAA - Admission of Resident Students as submitted. Ms. Fry seconded; the motion carried unanimously.

**JFABC – Admission of Transfer Students – Mr. Schalk**

The ASBA Advisory adds language – *The District may evaluate the transcripts of transfer students for the assignment of credit pursuant to Section 15-701.01.*

The changes are a direct result of change in statute as referenced. My recommendation is to adopt JFABC as submitted.

**MOTION:** Mr. Schalk made a motion to adopt policy JFABC – Admission of Transfer Students as submitted. Mr. Neff seconded; the motion carried unanimously.

**JFB – Open Enrollment – Mr. Schalk**

TVUSD policy language is significantly different from ASBA language.

The ASBA Advisory is recommending very specific language be removed from the policy is – *A school shall not admit a pupil if the admission of the pupil would violate the provisions of a court order of desegregation or agreement by a school or district with the United States*

***Department of Education Office for Civil Rights directed toward remediating alleged or proven racial discrimination.***

The changes from ASBA are based on changes in statute A.R.S 15-184(I). My recommendation is to remove the specific language as recommended by ASBA. Policy JFB will need to be reviewed thoroughly and will be brought back to the Governing Board at a later date.

**MOTION:** Mr. Schalk made a motion to adopt policy JFB – Open Enrollment specifically removing the language as recommended by ASBA – all else remains the same in the policy. Ms. Fry seconded; the motion carried unanimously.

**JL – Student Wellness –Ms. Fry**

ASBA is adding language with this advisory that addresses Sunscreen: *The goal is to emphasize skin health and promote the application of sunscreen products and to inform students that a student who attends school in this District may possess and use a topical sunscreen product while on school property or at a school-sponsored event without a note or prescription from a licensed health care professional.*

The addition of this language is based on changes in statute: A.R.S. 15-158, A.R.S. 26-894, A.R.S.36-897.12 and A.R.S 36-3916. Therefore, my recommend is for the Board to adopt the recommended change from ASBA in our policy language.

**MOTION:** Ms. Fry made a motion to adopt policy JL – Student Wellness as submitted. Mr. Neff seconded; the motion carried unanimously.

**KB – Parental Involvement in Education – Ms. Fry**

ASBA is eliminating language that requires *the right of a parent to participate in a parental satisfaction survey pursuant to A.R.S. 15-353.*

The elimination of the language is based on changes in statute A.R.S. 15-102. My recommendation is to adopt policy KB as submitted.

**MOTION:** Ms. Fry made a motion to adopt KB – Parental Involvement in Education as submitted. Mr. Schalk seconded; the motion carried unanimously

**6. ANNOUNCEMENTS**

Mr. Ruiz asked Taylor Nye to please to tell everyone what her interests are, Ms. Nye stated she is the Vice President of National Honor Society, she is on the Basketball team, she is in Girl Scouts, she is a member of the Math Club, and she is the Vice President of the Chemistry Club.

Mr. Ruiz asked how students were selected to become Student Board members. Mr. Malis indicated he asks the teachers (those teaching juniors). He places all the names on a list, and then he speaks to the counselors.
