- b. Special Education Board Policy and Operating Procedures approval Mrs. Franckowiak noted that there were no changes to the Special Education Board Policy and Operating Procedures this year. The school will be providing the students with their food handlers permit to allow them to run the student led coffee bar on campus open to parents, students and some local businesses. The students determine the menu and prices. They will learn how run a small business while gaining employability skills such as effective communication skills as well as customer service skills as well as some ethical training.
