Work Session Monday, August 15, 2016 Minutes

The Randolph County Board of Education met for a work session on Monday, August 15, 2016 at 4:30 p.m. in the Central Services Boardroom, located at the 2222 South Fayetteville Street Office in Asheboro. The following board members were present at the work session: Todd Cutler (Board Chair), Gary Cook (Vice Chair), Brian Biggs, Tracy Boyles, Fred Burgess, Emily T. Coltrane, and Matthew Lambeth. Also present were Dr. Stephen Gainey, Superintendent, and the Leadership Team members.

The work session started at 4:30 p.m.

Curriculum & Instruction Division

1. Overview of 2016 revisions of NC Math I, II, and III to NC Math 1, 2, and 3 Catherine Berry, Assistant Superintendent, shared that on June 2, 2016, the North Carolina State Board of Education approved revisions to the North Carolina Course of Study for Math 1, 2, and 3. Ms. Berry presented an overview including a timeline, implementation steps by the state, and implementation steps by the Randolph County School System. The information also has been communicated with principals and teachers.

Operations Division

1. Utilizing Advanced Imaging Systems (AIS) for the scanning and storage of student records Assistant Superintendents Catherine Berry and Marty Trotter shared that a team of individuals in the student services and technology departments have been working the past year on evaluating the school system's processes for scanning and maintaining student records. Advanced Imaging Systems Inc. (AIS) is a management company located in Pineville, NC. AIS is providing high-quality document management solutions specific to the K-12 market within North Carolina. AIS and its partner, Scribbles Software, have teamed up to provide school systems in North Carolina with solutions to better manage student record files containing sensitive information, increase staff productivity, and generate revenue for school districts. Ms. Berry also shared as a reminder that on June 29, information was presented at the Board meeting regarding Scriborder processing transcripts beginning September 1. Revenue from Scriborder will be placed into AIS to use for the scanning and storage cost.

2. Athletic ejection practice

Marty Trotter, Assistant Superintendent, presented the North Carolina High School Athletic Association (NCHSAA) ejection policy. Mr. Trotter shared that the ejection policy applies to all who are involved in an athletic contest including students, coaches, managers and game administrators. Examples of behavior/conduct as well as the penalties were reviewed along with data from the NCHSAA regarding ejections for the 2015-2016 Fall sports season.

Mr. Lambeth arrived to the meeting at 5:15 p.m.

3. Alternative education option for students who are long-term suspended Catherine Berry and Marty Trotter reviewed the plan for the alternative education option for students who are long-term suspended. This plan was first presented to the Board of Education during a work

session on October 19, 2015. Ms. Berry and Mr. Trotter shared there were no changes to the plan; therefore, this same plan will be implemented for the 2016-2017 school year.
