Superintendent's Comments:

Mr. Henson stated he has been at the Board of Education Office for 15 years, principal for 3 years, and served as assistant principal so he has been in areas to see the start-up of the school system. Mr. Henson stated this was the smoothest start-up the school system has ever experienced.

Mr. Henson stated those children riding the bus for the first time are a huge responsibility for both getting off the bus at school and getting home in the afternoon. Bus routes on a normal day end at 4:45. Mr. Henson stated on the first day of school the bus routes were complete at 4:50, and they have only gotten better since then. Mr. Henson stated the Transportation Department does an excellent job getting their students to school and back home.

Mr. Henson stated the Fannin County High School Open House for the freshmen students was a success. Parents and students gathered in the cafeteria with standing room only – All 330 seats occupied. Mr. Henson stated the students were able to meet their homeroom teacher, and then visited each classroom and teacher on their schedule for 20 minutes. Mr. Henson commended Mr. Cioffi and his staff for a successful Open House and states it is something that will be done again.

Mr. Henson stated he commends the Transportation Department, teachers, and staff on such a great school system and for making the students their number one goal and priority.

Board Members' Comments:

Steve Stanley thanked the teachers, staff, and everyone who attended the board meeting and taking an interest in the students. Mr. Stanley stated it is a community affair, and we are all in this together.

Sandra Mercier stated she is humbled and proud to be a part of the school system. Mrs. Mercier stated she had heard positive comments regarding the Open House from her granddaughters who are very pleased with the school year. Mrs. Mercier stated she realized how much work goes into it and the hard work that is done from the central office, teachers, and the entire school system. Mrs. Mercier stated we have one of the finest school systems around, and she is proud to be a part of it.

Lewis DeWeese reiterated Mrs. Mercier's statement of how proud he is of how hard everyone in the school works to do the right thing for our students.

Terry Bramlett stated it was an honor to be a part of the school system, and hats off to Mr. Cioffi for the success of the Open House. Mr. Bramlett thanked Mr. Long for running a successful transportation department and getting students home safely. Mr. Bramlett thanked Ron and Cecilia Scherer for giving up a portion of their land and the City of Blue Ridge for doing the work to make the entrance at the Middle School more visible and safer.

Bobby Bearden stated he agreed with his fellow board members' comments. Mr. Bearden also commended Doug Collins for his support of the football coach from Chestatee High School.
