Revelation Christian Academy (RCA) has updated their COVID-19 school reentry plan to be implemented for the 2021-2022 school year. When creating this plan, it was the intent to be in accordance as best as possible with the recommendations from the Center of Disease Control (CDC) and the Alabama Department of Public Health (ADPH). At this time, the CDC recommends for anyone that has not been vaccinated to continue to wear a face mask. That includes any child that is 11 years old or younger. At this time, students and staff will be required to wear a face mask throughout the day. All parents entering the daycare facility will be required to wear a face mask before entering.

The mission of this plan was to develop ways to maintain a safe learning environment while continuing to service students of RCA while dealing with COVID-19. The following areas were considered when creating this plan: *transportation, arrival/dismissal, breakfast/lunch, student interaction, disinfection/sanitation, personal protective equipment (PPE), supplies, common areas, social distancing.*

Transportation

Transportation is provided for field trips and before and after school care. Students of RCA will be transported to and from the daycare campus for the before and after school program. The van will be sanitized daily after transporting students.

Arrival/Dismissal

As the students enter, they will be evaluated for any type of sickness, (sore throat, cough, running nose, etc.) Students will also have their temperature checked and recorded 2 times a day. After passing the temperature check point, students will proceed to the restrooms to wash their hands. If a child will not be eating breakfast, they will proceed to their classroom beginning at 7:40 AM.

Students will be dismissed from their classes as their names are called utilizing 2-way radios on both campuses.

Breakfast/Lunch

Breakfast and lunch will be prepared and transported from the daycare to the elementary campus. Breakfast and lunch will be served in the gymnasium. Students will have the opportunity to eat breakfast before going to class. When coming to lunch, students will sit 4 to a table. Teachers will pass out lunches to the students instead of students being served from the food line.

Student Mixing

Students will be isolated in their classrooms for most of the school day except for traveling to the restroom, traveling to lunch, and traveling to activity classes.

Activity Classes

Students will travel to activity classes with their classmates. Classes will not be grouped with other classes. Physical Education will be held outside as often as possible.

Disinfecting/Sanitation

Teachers will disinfect all commonly touched surfaces throughout the day, (doorknobs, tabletops, student desks, etc.) Air purifiers have been placed in each classroom as well as, throughout the building. In the event of a reported COVID case, the classroom and/or building will be sanitized by the building superintendent. Hand sanitizer will be available in the classroom and at the entry and exit door.

Personal Protective Equipment

Students and teachers will be required to wear their masks throughout the day.

Supplies

Students will be encouraged not to share classroom supplies. Classroom supplies that cannot be disinfected will be limited to use by only one person.

Common Areas

Students will practice social distancing in the common areas. Only 2 students will be allowed in the restroom at one time. Water fountains will be disconnected. Students will be allowed to bring in a sports bottle to drink water throughout the day. Parents will not be permitted to come upstairs to the classrooms unless they can provide proof of vaccination and/or permission has been granted. If a child gets an early dismissal, he or she will be escorted downstairs to be signed out.

Social Distancing

Students and staff will practice social distancing. Student desks will be spaced out. Only 4 students will be allowed to sit at a table during lunch. Students will also be spaced out during activity classes.

Health Screening

Students and staff will have their temperature checked and recorded 2 times a day. Students nor staff will be allowed to come in the building with any signs of being sick. If a student or staff has a fever of 100 degrees, they will not be permitted to remain at school. They will be placed in an

isolated area. Neither will they be able to return until fever free for at least 24 hours without medication.

If a student or staff person is exposed to someone that has COVID then,

- the student or staff person will be required to quarantine for 5 days
- while in quarantine, if the student or staff person begins to develop any symptoms, the student or staff person will be required to take a COVID test before returning.

If a student tests positive for the COVID then,

- parents of the remaining students will be informed of the case.
- the students and teacher of the specific class will have to quarantine for at least 5 days
- while in quarantine, if the remaining students or staff person begins to develop any symptoms, the students and/or staff person will be required to take a COVID test before returning.
- the teacher will conduct virtual learning sessions
- the classroom will undergo a deep cleaning.

If a teacher tests positive for the COVID then,

- parents of the teacher's students will be informed
- students and the teacher will have to quarantine for at least 5 days
- while in quarantine, if the students begin to develop any symptoms, the students and/or staff person will be required to take a COVID test before returning
- the students will receive a take home packet to complete
- the classroom will undergo a deep cleaning.

If a student that tested positive for COVID has a sibling at either campus,

- the sibling must be quarantined for at least 5 days
- while in quarantine, if the sibling begins to develop any symptoms, the sibling will be required to take a COVID test before returning

If a student is required to quarantine due to being exposed to his/her teacher or a classmate that has tested positive, then the currently enrolled sibling (s) of that student will be required to quarantine as well.

If 10% of the daily total of persons in the Family Life Center building test positive for COVID the school will close for sanitizing for a minimal of 5 days. If a child or staff begins to develop symptoms while in quarantine, he or she will be required to get tested before returning.

If 10% of the daily total of persons in the daycare facility test positive for COVID the daycare will close for sanitizing for a minimal of 5 days. If a child or staff begins to develop symptoms while in quarantine, he or she will be required to get tested before returning.
