6. Updates on 2024-2025 Fall sports season: <u>Cross Country</u>

The fall 2024 campaigns for both the girls' and boys' cross-country teams were defined by senior camaraderie and leadership, with five seniors – Arianna Gaylord, Hannah Stoss, Owen Klaproth, Shane Emsley, and Colby Walsh. The girls team returned all runners from last year's 10-6 squad and were ready to improve on that mark before untimely injuries to Addi Gaylord and Sophia Tang left them shorthanded for team scoring. Nevertheless, led by this year's "Heart of the Team" Arianna Gaylord, the girls retained a strong team bond that inspired great individual results from Kierstyn Orlandini, who secured a trophy at the highly competitive Lackawanna Commissioners' Invitational, and from team MVP Hannah Stoss, who medaled at the prestigious Cliff Robbins meet, the Commissioners' Invitational, and the Wyoming Valley Conference Championships. For her outstanding running, Stoss was named a conference all-star by both the WVC coaches and the media for the third consecutive season. The boys' team was led by team MVP

Colby Walsh, whose work ethic at practices and tenacity on race days set an example for our underclassmen to follow in the years to come. Walsh enjoyed a fitting end to his career by medaling at both the WVC Championships and the District II Championships. In winning five meets this season, the team received valuable contributions not only from its seniors but also from junior Chris Viadock and sophomores Ben Start and Elliott Stoss.

Program Note: WAXC has now won at least one WVC Championship individual medal for the 7th consecutive year and one District II individual medal for the 6th consecutive year.

Field Hockey

The team had their first undefeated regular season in school program history (16-0) and also won the Wyoming Valley Conference title this year as well. 
Marching Band

Vanessa Smith of Exeter asked how are the kids being split decided. Dr. Pollard responded they have been split up several other times because of lack of subs so they will follow the same pattern to even everyone out. Parents will be notified. If we get enrollment back to the levels we've experienced it will be automatically reinstated.

Nikki Milcavage, West Pittston, commented that she hoped it would be explained to the kids what is going on so that they do understand especially with new rules and they are at different spots in the curriculum.

Peter Butera, Board Member, stated that he hears their concerns and it matters a lot to him personally and he also stated that if you collapse a position for the rest of the year there's a savings of \$2,000.
