# REGULAR MEETING OF THE SANTA MARIA JOINT UNION HIGH SCHOOL DISTRICT BOARD OF EDUCATION March 13, 2018

A regular meeting of the Board of Education of the Santa Maria Joint Union High School District was held on March 13, 2018 with a closed session at 5:30 p.m. and an open session at 6:30 p.m. Members present: Perez, Palera, Lopez, Garvin, Karamitsos

## **OPEN SESSION**

Ms. Perez called the meeting to order at 5:30 p.m. There were no public comments. The meeting was immediately adjourned to closed session.

## RECONVENE IN OPEN SESSION

Ms. Perez called the meeting to order at 6:30 p.m. Dr. Karamitsos led the Flag Salute.

Dr. Richardson announced the closed session items. All personnel actions were approved as submitted. The Board voted 5-0 on non-reelection of one probationary certificated employee. The Board was updated regarding labor negotiations with both classified and certificated personnel. The Board approved student matters as presented. There was a conference with legal counsel regarding a potential litigation matter.

It is amazing to think it happens every day and unfortunately, we only hear about the negative things. He thanked everyone for the all the work they do.

He wanted to let the students know that administration is in support of the student efforts to have the peaceful protest for the students in Florida. He commended the students for planning the event.

## **Board Member Reports**

Dr. Karamitsos: She had the opportunity to visit the CTE site with Dr. Richardson. It is a great location and you can see Righetti High School from the site. She is looking forward to having the project move forward.

Dr. Garvin: He had the opportunity to visit Righetti High School and do a tour of the new building. The staff and administration has done a great job handling the noise with all the building that is going on. There was a Job Fair/Career Fair in the Gym that day and it was great to see the students and staff participate. He was also lucky enough to be there for Taco Tuesday! He and Ms. Perez went to PVHS and SMHS. He thanked Ms. Herrera for organizing everyone to talk with them. The Activities and Athletic Director shared their events and the Counselors were there as well. He is impressed with the support programs and staff that are helping the students. At SMHS he spoke with Mr. Domingues and attended the Academic Awards which had a great turnout. He participated in contractor interviews for the CTE project and SMHS project. He is also impressed with how great the campuses look.

Ms. Lopez: She spoke about the Youth of the Year contest in Santa Barbara. The Santa Maria Valley student was chosen from PVHS. They went to the Santa Barbara Zoo where the student competed against other students from Simi Valley to Northern California. The winner was a senior out of Oxnard but our student did amazing. She attended the Por Vida meeting at SMHS and Ramsey Jay Jr. was the speaker. She hopes the schools can bring him back so he can deliver his speech to other students. It was very empowering. In a few years these young people will be making the decisions.

Ms. Perez: She attended the board walks at PVHS and SMHS. She thanked Ms. Herrera. Great perspective at PVHS about what happens at a high school. It was a great presentation from the staff. She thanked Mr. Domingues for a review of the high school and getting the latest information. A number of students participated in the YELL conference at Hancock. Financial season is now over for students. PVHS and SMHS did a great job in getting students to fill out FAFSA's.

# <u>Award of Bid for Districtwide Core Switch Replacement – Project #18-277</u>

District administration opened bids on February 20, 2018, for the DISTRICTWIDE CORE SWITCH REPLACEMENT – PROJECT #18-277. The bid recap and administrative recommendation follows:

After reviewing the bid(s) received by administration, CIO Solutions was determined to be the initial apparent low bidder; however an irregularity was identified in their bid package, specifically failure to include the required bid bond. Dell, the second lowest bidder, had an irregularity identified in pricing. GigaKOM is the apparent lowest responsive bidder.

A motion was made by Dr. Garvin and seconded by Dr. Karamitsos to find the CIO Solutions bid non-responsive due to their failure to include the required Bid Bond with their bid per the specified requirements. The motion passed with a vote of 5-0.

A motion was made by Dr. Garvin and seconded by Ms. Lopez to find the Dell bid non-responsive due to an irregularity in the pricing. The motion passed with a vote of 5-0.

A motion was made by Dr. Garvin and seconded by Ms. Lopez to award the bid for Districtwide Core Switch Replacement – Project #18-277 to GigaKOM, to be paid from the General Fund/E-Rate Funding. The motion passed with a vote of 5-0.

## Award of Bid for PVHS-Pool Lights Install & Column Repair – Project #17-251

The administration opened bids on March 7, 2018 for the PVHS - POOL LIGHTS INSTALL & COLUMN REPAIR - PROJECT #17-251. The bid recap and administrative recommendation follows:
