***Leah Swanson Memorial Fund***  
**Standard Operating Procedure (S.O.P.)**

---

**1. Purpose & Commitment**

The purpose of the *Leah Swanson Memorial Fund* is to provide financial support exclusively for students who are in need of essential PE/Athletics related items. These items may include but are not limited to ANY essential items necessary for safe and appropriate participation in Physical Education, as well as Athletics. **This fund exists to remove financial barriers to ensure all students have equitable access.**

Commitment Statement:

This fund is established with the explicit understanding that:

The *Leah Swanson Memorial Fund* will **never** be used for any purpose outside of supporting students in need of PE/Athletic related wear, as well as individual equipment.

*\* This commitment remains in effect indefinitely.*

**2. Fund Use Restrictions**

- The *Leah Swanson Memorial Fund* shall be used **ONLY** for assisting students in need of **PE/Athletic related** items.
    - Athletic Shoes
    - PE Appropriate Clothing
    - Recommended Team “Athletic Wear”
  - Under no circumstances shall this fund be used for:
    - General school expenses
    - Equipment purchases for staff or programs
    - Incentives, rewards, or non-essential items
    - Any purpose unrelated to direct student PE assistance
  - The existence of available funds does **not** justify or permit use for alternate purposes.

### 3. Longevity of Funds

- It is fully acceptable and expected that funds may remain unused for extended periods of time.
  - Funds may sit for **months or years** without being spent if there is no qualifying student need.
  - The passage of time or accumulation of funds shall **never** be used as justification to redirect or repurpose the account.
    - **Non-Transferability Clause** - At no point shall funds be transferred, borrowed, or reassigned to other accounts, programs, or needs – **regardless of fund balance.**

### 4. Accountability and Oversight

- All purchases made by the *Leah Swanson Memorial Fund* must be documented and tied directly to a student's need. (LSMF 'Open Arms' Application)
  - Records should include the type of item purchased, and/or the dollar(\$) amount, and for what activity it is intended.
- 

### 5. Eligibility and Approval

- ALL students within the Whitepine Joint School District are eligible for assistance when there is **legitimate** need for PE/Athletic - related items due to financial hardship or lack of access.
- All expenditure must be approved by these designated personnel - the **family of Leah Swanson**, the **Athletic Director**, and the **HS Principal**.
