

# REQUEST FOR PROPOSAL Walkway Canopy

Furlow Charter School is soliciting quotes from licensed general contractors for providing labor, material and equipment to construct a walkway canopy from the existing walkway canopy to a new modular building.

## <u>Proposals must meet ESSER Federal Funds guidelines specifically in regards to 2 CFR Part</u> 200.322, Domestic Preferences for Procurement, and the Davis Bacon Wage Determination.

#### SCOPE OF WORK

- 1 18' x 56' Covered structure over Handicap Ramps at High School.
- Approx 600 linear ft of <u>Covered Walkways</u> and <u>Canopies</u> at various widths to ensure traffic is unimpeded, the entire sidewalk is covered to and from the modular and main building, and compatible with current awnings/covered walkways. See attached map for areas to be covered.
- Alum 3" sq post with thickness of 1.50
- Flat pan roofs with thickness of .032
- Guttering with a thickness of .050
- Layout and Design required by the contractor awarded the project.
- Site supervision required at everyday work sessions.
- Work times are regulated through the maintenance department to comply with school loading, unloading and class changes during school hours.
- All materials and Labor shall comply with international building codes, Local and State Codes.
- Contactor to list 3 commercial projects in like manner.
- Contractors are required to have a current state contractor's license.
- Contractors are required to carry Work compensation & General Liability with \$2,000,000.00 coverage.
- Please provide 2 quote options one quote covering the roadway (portion above roadway must be tall enough to accommodate garbage trucks, semi delivery trucks, etc.) and a second quote without the roadway covering (creating a gap).

## FORM OF PROPOSAL

Proposals should consist of the following information:

- Identification of the point of contact for this RFP process with phone number and email
- Anticipated project start date and timeline, if awarded
- Experience and qualifications of employees that would be assigned to this project
- Itemized list of proposed costs and time of delivery
- Verification that the project can be completed by June 30, 2024

#### **Furlow Charter School District Requirements**

- FCS intends to continue school business functions during the project through June 2024. The contractor must coordinate the services schedule with the Principal or Assistant Principal of the school. This project must not interfere with any school business function.
- Proposers shall carefully examine the work site to obtain first-hand knowledge of existing conditions. A site visit is **required** prior to proposal submission and must be arranged with Thomas Sumner at 229-942-4488.
