Method of Nomination:

- No limitation will be placed on the number of nominations submitted for consideration, however, only one nomination will be accepted for each individual. The name of the nominator will not be disclosed to the selection committee
- The standard nomination form, provided by the committee, must be used in nominating an individual.
- A picture (5 x 7 color glossy) of the nominee is requested as part of the nomination. These photos will be used to announce the award recipient. It will also be used on a plaque that will be hung in the foyer at Slidell Jr/Sr High School. Please be sure to include a recent picture.

Criteria for Selection:

The following criteria should be used in nominating graduates for an award:

- **Professional Attainment:** The recipient should have attained prominence through his/her efforts in commerce industry, technology, the professions, agriculture, the arts, government or other worthy endeavor.
- **Inspirational Qualities:** The recipient should be a person of integrity, stature and demonstrated ability that the Slidell community, current students and former students will take pride in and be inspired by his/her recognition.
- **Renowned Achievements:** The recipient shall have a record of accomplishments impressive to the citizens and students of Slidell, Texas.
- **Demonstrate Loyalty**: The recipient shall, by his/her deeds and actions, reflect the importance of his/her education.

Eligibility:

Nominees must meet one of the criteria below:

- Graduated from Slidell HS. The nominee must have a graduation date of a least 25 years before being eligible for the award.
- Candidate may a district employee whose service was of an Exemplary nature
- Citizen whose contribution to the district made a significant difference in the lives of students & faculty at Slidell ISD
