- Demonstrate creative and innovative lesson plans that contribute to a highly engaged learning community
- Establish and communicate clear objectives for all learning activities
- Participate in professional development opportunities and demonstrate a commitment to continuous learning
- Provide timely and informative feedback to formative and summative assessment tasks
- Use grading practices that achieve the purpose of grades, which indicate the extent of learning
- Communicate student progress and development with parents, staff, and administration
- Provide a flexible and stable learning environment that is child-centered while maintaining appropriate classroom management
- Use technology to support learning
- Effective positive communication skills
- Maintain a calm demeanor when dealing with a crisis/violent situation
