When you finish this training, please email me at dolszewski@jp2falcons.org, to let me know that you have completed the course and what activity you are volunteering for. Then, I will watch for your background results and print your training certificate.
- 3. Finally, fill out the Diocese of Birmingham in Alabama Driver Information Sheet. (This particular piece must be updated yearly).

Please bring the completed documents to the school's front office to my attention: <u>Diane Olszewski, Volunteer Coordinator</u>. At that time, I will process your request which normally takes about two-to-three days. When I receive your clearance, I will email you to let you know that you may start volunteering.
