Treasurer's Report – Joe Aliperto, Dieci Finance

- ADM 143 right now, tracking with budget of ADM 141, so in line with what we anticipated – the recent change will show up next month (Chris clarified)
- Fund balance continues to be solid (Just over 30%), no concerns
- 83% of the way through the year have received 83% of money, spent 81%
- No news about grants
- New education budget came out and EL revenue could change for us.
- State is looking at 4% gen ed formula increase, then after that 2% base, up to 3% depending on inflation
- Donations
- \$500 donation
- Joe talked through financial reports, everything in line with expectations
- Next year moving back to all students eat free this looks like it will also work out financially with higher reimbursements for us

- Basing on ADM of 141
- Revenue
 - 4% gen ed aid increase
 - More compensatory revenue (based numbers of free and reduced lunch)
 - This data is easier to collect when families need forms for lunch, but with all meals paid for, we will have to collect info differently perhaps for most accurate compensatory revenue
 - o EL funding is going up a little bit, may result in about \$17000 more next year
 - o SPED funding?
 - ACCESS grant we applied by first deadline but haven't heard yet
 - Some grants are going away (COVID monies)
 - Wages projected to go up 4% based on state increase and benefits will increase too
 - Lease aid is based on ADM
- Jean pointed out that losing ESSER money and some large donations that we can't rely on forever means we need to continue to look for funding sources.
 - Tyler is meeting with grant writer what does she think about money available
 - Equity funding seems promising
 - Meeting again soon all are invited to this virtual meeting
- Sarah question about the 30,000 feet look at finances, how to get a big picture overview, calendar of when things are considered and discussed, etc.
 - o Finance committee is working on this already
