In support of strengthening student academic achievement, the Lanier County School District receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(a)(2) of the Every Student Succeeds Act (ESSA). ## **Family Engagement for Shared Student Achievement**

### **What is it?**

The policy establishes Lanier County Schools' expectations and objectives for meaningful parent and family engagement and describes how the district will implement several specific parent and family engagement activities, and it is incorporated into the district's plan suited to the Georgia Department of Education.

### **How is it revised?**

Lanier County School District invites all families and community members in the spring to revise the district level policy where they received a copy of the policy for review. Families may receive and review copies of the policy at school level meetings and compact revision meetings. Surveys are completed annually in the spring and results from the surveys are used to revise and improve the district policy.

### **Who is it for?**

All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this policy. The Title I schools will provide full opportunities for the participation of families with limited English proficiency, limited literacy, disabilities, migratory children, who are economically disadvantaged, or are of any racial or ethnic minority background, including providing information and school reports required under Section 1111 of the ESSA.

### **Where is it available?**

The Parent and Family Engagement Policy is made available to all parents and community members. A paper copy of the policy is made available to families who attend stakeholders' monthly meetings, in the school board office, the lobbies of all Title I schools, and the parent resource room. A digital copy is available on the district website.

## ANNUAL EVALUATION

The Lanier County School District will take the following actions to conduct, with the meaningful involvement of parents and family members an annual evaluation of the content and effectiveness of this parent and family engagement policy in improving the academic quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in activities (with attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parent and family engagement policy to design strategies for more effective parental involvement and to revise, if necessary, its parent and family engagement policy.

A district-wide Title I advisory meeting will occur annually with the aim of evaluating the content and effectiveness of the Title I Parent and Family Engagement Policy in improving student achievement. The school district will revise its Parent and Family Engagement Policy based upon the annual review. The evaluation process will include:

- Conducting an annual evaluation of the content and effectiveness of the Family Engagement Policy, with assistance of its schools and parents.
- The Federal Program Director and the school's Parent and Family Engagement Coordinators will conduct an annual evaluation with the use of parent surveys (that can be completed online or paper copies) and focus groups to determine whether the content of this family engagement policy has been effective.

- Coordinators will share annual evaluation findings at spring stakeholders and parent input meetings.
- Each school conducts needs assessment and maintains and submits documentation of family engagement activities and parent/family contacts to the Federal Program Director.
- Family engagement program evaluations occur at the conclusions of workshops, meetings, and other parent events.
- Families' and community members' participation in the annual survey is advertised and completed through the district and school websites, handouts, and newsletters.
- The findings of the needs assessment, parent contact logs, evaluation of parenting activities, and survey will be used for improving schools and the Title I program. The system's family engagement policy will be revised and strategies will be designed to reflect suggestions and recommendations of families, teachers, and administrators when feasible.
- If families are still not satisfied with the policy, their comments will be submitted with the policy to the Georgia State Department of Education for review.

## **RESERVATION OF FUNDS**

The Lanier County School District will involve the parents and family members of children served in Title I, Part A schools in decision about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent and will ensure that not less than 90 percent of the 1 percent reserved goes directly to Title I schools.

- School advisory council will be composed of parents/families with children who attend Title I schools and receive Title I services to talk in an effort to collaborate on how the 1 percent of Title I, Part A funds will be spent.
- The district will annually review the Parent and Family Engagement Policy and the Federal Program Director will complete a checklist to ensure that all required components are addressed.
- The Federal Program Director/coordinators will annually present the Parent and Family Engagement Policy to parents during a district level meeting.
- Families will complete the Annual Parent Survey and Title I Program evaluation. The results will be reviewed by families and staff.
- Family notifications to participate in the revision of the Comprehensive LEA Improvement Plan (CLIP) and Title I Parent Advisory Meetings will be advertised at the district and school level.

## **COORDINATION OF SERVICES**

The Lanier County School District will coordinate and integrate parent and family engagement strategies with family engagement to the extent feasible and appropriate with other relevant Federal, State, and local laws and programs:

- The district Title I staff shall provide coordination, technical assistance and other support necessary to assist participating schools in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance. The district Title I staff and principals shall coordinate family engagement strategies, programs, and activities, to the extent feasible and appropriate, with such programs as Head Start, Early Intervention Program (EIP), Remedial Education Program (REP), and Bright from the Start – Georgia Department of Early Care and Learning (BFTS).
- Staff from the Title I program, Bright from the Start – Georgia Department of Early Care and Learning, Head Start, State run preschool programs will attend workshops and conferences together, if appropriate. All programs will coordinate parenting activities, information and resources to maximize family engagement. As appropriate, parents from each of the programs will be invited to attend joint family engagement activities. The school principals, Resource Coordinators, Head Start Director, Bright from the Start, Kindergarten teachers, and Family Connection Director will collaborate on transition activities from primary, elementary, middle, and high school.

## **BUILDING CAPACITY OF PARENTS**

The Lanier County School District (LCSD) will build family's capacity for strong engagement to ensure effective involvement and to support a partnership among the schools involved, families, and the community to improve student academic achievement through the following activities described below:

The school district will, with assistance of its Title I, Part A schools, aid families of children served by the school district or school, as appropriate, in understanding the following topics, by undertaking the actions described in this paragraph: The State's academic content standards.

- The State's student academic achievement standards
- The State and local academic assessments including alternate assessments
- The requirements of Title 1, Part A
- How to monitor their child's progress

This is done during annually scheduled Title 1 Parent Meetings that are held at each school at the beginning of the school year. Title I teachers at each school distribute information and communicate with families of their child's grade level standards. Meetings for the 2024-2025 school year will be held prior to November 1, 2024.

Activities may include:

- Parent workshops concluded with program evaluations
- Curriculum-based events based on school defined academic goals such as: College and Career Ready Performance Index (CCRPI), Math/Science, and Curriculum Night events that may highlight state assessments Georgia Milestones and Student Learning Objectives
- School and District Parent Advisory Council
- Transition opportunities
- Parent/Teacher Conferences
- District and School Level Title I Parent Meetings and Comprehensive LEA Improvement Plan (CLIP) meetings
- Explanation of testing and student results

Families are invited by school newsletter, school and district websites, district and school notification system, and other forms of social media.

The school district will, with the assistance of its schools, provide materials and trainings to help families work with their children to improve their children's academic achievement and foster family engagement by:

- Offering family workshops at each Title I school during different times of the day (morning and evening) to accommodate families' work schedules. Topics for workshops are based on identified needs from surveys, teacher input, and student performance data. Some workshops are in collaboration with the English Language Proficient, students with disabilities, Homeless, Foster Care Children, Migrant, and Pre-K program. Childcare may be provided when feasible.
- The district provides for parents, literature that offer academic support and assistance for their child at home. Resources available to parents are books and videos about parenting, math and reading skill building, and homework assistance.
- LCSD will provide information related to school and family programs, meetings, and other activities to parents/families in a format to the extent practicable, in a language that families can understand.
- LCSD will involve families, as described by law, in the development of training for teachers, principals, and other school staff members to improve the effectiveness of the training.

### **BUILDING CAPACITY OF SCHOOL STAFF**

The school district will, with the assistance of its schools and parents, educate its teachers, student services personnel, principals, and other staff on how to reach out to, communicate, and work with families as equal partners, in the value and utility of contributions of families, and how to implement and coordinator family programs and build ties between families and schools by:

- Reviewing parent and family engagement evaluations with school personnel and determine what can be done to assist with families' needs
- Promoting cultural understanding to all staff at Title I schools
- Providing as allowable, opportunities for parents to volunteer at their child's school and offering training sessions led by parents



- Develop jointly the School-Parent Compacts
- Training of school staff through workshops and/or online resources to promote working with families as equal partners. Parent and Family Engagement Coordinators will promote and train staff on effective two-way communication with families.
- Collaborating and integrating to the extent feasible and appropriate, parent and family engagement activities with other programs such as Early Intervention Program (EIP), counselors, Pre-K Programs, Neglected & Delinquent (N&D) Institutions, Head Start, Homeless, Foster Care Children, Safe and Drug Free Schools, Limited English Proficient, Private Schools, Adult Education, and Migrant and to integrate parent and family engagement strategies and programs.
- Maintaining regular two-way communication regarding curriculum and testing
- Providing access to parent training materials and parent training opportunities through the Parent Resource Center/Room

The school district will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities is sent to the families of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand and utilize contracted services of translators as needed.

## **SCHOOL-PARENT COMPACTS**

As part of this plan, all Title 1 schools, along with our families will jointly develop school-parent compacts in order to build and develop school-parent compacts in order to build and develop a partnership to help our students and challenging state academic standards. These compacts serve as agreements that parents, teachers, and students will work together to make sure all students reach grade level standards by following and accomplishing goals set forth by parents, teachers, and students. The compacts will be revised annually, distributed to all families, reviewed at parent/teacher conferences.
