What is Title I?

FCMS is identified as a Title I school as part of the Elementary and Secondary Education Act of 1965 (ESEA). What is it?

This is a plan that describes how FCMS will provide opportunities to improve parent engagement to support student learning. How is it revised?

FCMS invited all parents to attend our annual stakeholder meeting last spring to review and revise this parental involvement policy, as well as the schoolwide plan, our school-parent compact and the parental involvement budget. Who is it for?

All students participating in the Title I, Part A program, and their families, are encouraged and invited to fully participate in the opportunities described in this plan. FCMS will provide full opportunity for the participation of parents with limited English, parents with disabilities and parents of migratory children to contribute.
