

REQUEST FOR PROPOSALS

CHRISTIAN COUNTY HIGH SCHOOL APPLIANCES

The Christian County Board of Education requests sealed proposals for the purpose of selecting an appliance package for the new Christian County High School located at 5185 Ft. Campbell Blvd., Hopkinsville, KY 42240.

Proposals will be received until **1:00 p.m., March 2, 2026** at which time proposals will be opened. Proposals must be sealed in an envelope that is clearly marked "**CCHS Appliances**" and delivered to the Christian County Board of Education, 200 Glass Ave, PO Box 609, Hopkinsville, KY 42240; ATTN: Jessica Darnell.

The District reserves the right to accept or reject any and all bids and to waive any informality in bids if that action is in the best financial interest of the Board. Any questions can be directed to Jessica Darnell at (270)887-7006.

The intent of this Request for Proposal (RFP) is to solicit sealed proposals for the listed appliances. Proposals should include unit price for each item and quantity listed, delivery to the site, and removal of refuse. Final installation and connections will be made by contractors on-site. Delivery of the items shall be scheduled with the owner. Delivery of appliances may start as early as April 13, 2026 but shall be delivered no later than May 15, 2026.

Proposals and pricing must be submitted for the entire scope of services contained in this RFP. The District reserves the right to waive any informalities, qualifications, irregularities, and omissions or reject any or all proposals if it determines that proposals are not responsive to the RFP or the proposals themselves are judged not to be in the best interest of the District. All vendors submitting proposals agree that their pricing is valid for a minimum of one year after proposal submission.

All appliances are presumed to be residential in quality with the exception of the commercial washer/dryer sets noted. All appliances shall come with a minimum of 12 month warranty to begin on July 1, 2026 or upon delivery date, whichever is the latest date. All appliances shall be like brand, color, and sizes as noted in the table below.
