## 6. Public Comments on Agenda Items

A concerned citizen asked if volunteers are required to do a background check. Superintendent Shepherd let them know that yes that is a requirement. They also asked if an explanation was made to volunteers regarding the status of employment being considered "volunteer" and not an employee. Superintendent Shepherd explained that we in fact have a form that volunteers are required to read and sign indicating their status and explaining they are not considered an employee of the corporation.

A concerned citizen inquired if the meeting dates are still being changed. Superintendent Shepherd replied that item is on the agenda and will be discussed tonight. The same community member inquired about the new teacher contract and asked for a summary. Superintendent Shepherd explained that he would be covering this in item 7.

7. <u>Teacher Contract Tentative Agreement Public Hearing</u>
Chad Howell made a motion to open the hearing. Melanie Mills seconded the motion. ALL AYES!

Superintendent Shepherd explained to the board that a tentative agreement was given to the board in their packets for review. The main highlights of this two year contract are that our teachers will average about an 11.5% pay increase for certified staff. There are three different categories that were based on the staff member's years of experience. Negotiations were very amicable and Superintendent Shepherd was very pleased with how both sides handled the process. It is the second consecutive largest raise given to Tri-Township teachers which Superintendent Shepherd is pleased with. At this time Superintendent Shepherd opened the floor for public comments. A concerned citizen asked as insurance costs increase who absorbs the cost for these increases? Superintendent Shepherd explained that both parties are affected by the increases.

The same concerned citizen asked Superintendent Shepherd to verify that the minimum increase over the term of the contract is \$4,500 and what that increase is based on. Superintendent Shepherd verified the number and explained that the increases are based on years of experience.

The same citizen asked if there were any changes to fringe benefits. Superintendent Shepherd explained that there were changes to the extra-curricular schedule which occurred on a case by case basis. The same citizen explained he understands this is for the certified staff only but is wondering if increases will be being discussed for the non-certified staff. Superintendent Shepherd explained that is not being discussed at this time. Most positions in the non-certified category are based on years of experience.

Daron Bruder made a motion to close the hearing. Chad Howell seconded the motion. ALL AYES!
