RESOLUTION

Dedicating the Gadsden County School District Transportation in Honor of

Dr. Robert H. Bryant

WHEREAS, Robert H. Bryant began his career with the Gadsden County School District in 1957 as a teacher, was promoted to assistant principal in 1962, principal in 1970 and then appointed as the Assistant Superintendent for Employee Relations in 1977; and

WHEREAS, Robert H. Bryant made history in Gadsden County by becoming the first African American elected to the office of school superintendent in 1985; and

WHEREAS, Robert H. Bryant served as Superintendent until 1993 when he retired after a distinguished thirty six years of service to the public and especially to the children of Gadsden County; and

WHEREAS, Robert H. Bryant was a dedicated, talented and loyal public servant who treated everyone with respect and dignity throughout his career setting an example for all; and

WHEREAS, the building owned by the School District at 720 South Stewart Street serves as the hub for the school buses that transport children to and from the schools every day; and

WHEREAS, Robert H. Bryant's service to this community and historical accomplishments served as an inspiration, motivation, and hope to the citizens and students of Gadsden County and transported the School District into a new era; and

WHEREAS, this Board feels that it would be appropriate and fitting to dedicate the home of the Gadsden County School District Transportation Facilities at 720 South Stewart in honor of Dr. Robert H. Bryant.

NOW, THEREFORE, BE IT RESOLVED by Superintendent Reginald C. James and the School Board of Gadsden County, Florida pursuant to the authority granted under Section 1001.43, Florida Statutes, that the building located at 720 South Stewart Street, housing the Gadsden County School District Transportation Facilities be and is hereby dedicated and named in honor of Robert H. Bryant and that an inscription on the District Transportation facility's main building reflecting this honor be installed at this location and that this resolution be effective upon its adoption.
