Technology Update

- Duo We have started the rollout of Duo MFA (Multi-Factor Authentication) for Staff
 which are working over the summer. All other Staff & Faculty will be enrolled at the
 start of the school year. We are protecting applications such as our webmail, student
 information system, and VPN.
- 802.1X We have been testing 802.1X to further secure connectivity of wired devices
 on our network by ensuring that they are authorized, similar to a wireless network. We
 plan to roll this out to our Windows-based devices as early as September.
- PowerSchool OIDC PowerSchool logins are now integrated with Google to make it easier for Staff, Faculty, and Students to login and access their accounts. Parent access remains the same at this time.
