Navajo School Clothing and Supplies Applications Accepted Sooner Than Announced

Window Rock, Ariz. – The Navajo Family Assistance Services (NFAS) provides financial assistance for eligible school age Navajo children to purchase clothing and supplies, of their choice, in an effort to promote school attendance, encourage academic performance, and support self-confidence.

In a prior release, the NFAS office announced that they will accept applications for Navajo School Clothing and Supplies (NSCS) for School Year 2021-2022, beginning Monday, October 4, 2021.

The NFAS office would like to announce that a recent budget modification will allow for the NFAS office to accept applications for Navajo School Clothing and Supplies sooner. Applications will be available on Friday, August 27, 2021.

The applicant must submit the following required documents with an application to Navajo Division of Social Services, Office of the Executive Director:

- 1. The child's Certificate of Indian Blood;
- 2. The child's valid social security card;
- 3. A document on official school letterhead verifying the child is enrolled for the current academic year, or appropriate documentation verifying the child is home schooled or virtual learning.
- 4. Completed W-9 Form that is signed by the applicant.

Complete, signed applications with copies of required documentation may be submitted via postal mail, in-person, fax, email, or online as follows:

Applicants should be aware, all required documents must have matching names. If the required documents are not submitted, the application will be held until documentation is provided.

Eligibility:

The following requirements must be met for determination of eligibility:

- 1. The child must be between 3 to 18 years of age on the date the applicant submits an application.
- 2. The child must be enrolled member of the Navajo Nation.
- 3. The child must be enrolled in school, including home, or virtual learning.
- 4. The child must be enrolled in child care, Head Start, Pre-Kindergarten, Pre-school, and grade K through 12 for the current academic school year.

An applicant is only eligible to receive financial assistance from one of the following Navajo Division of Social Services programs:

- 1. NFAS' Navajo School Clothing and Supplies; or
- 2. Navajo Department for Self Reliance's TANF school clothing benefits.

Required documents:

- 1. The child's Certificate of Indian Blood;
- 2. The child's valid social security card;
- 3. A document on official school letterhead verifying the child is enrolled for the current academic year, or appropriate documentation verifying the child is home school or virtual learning such as, but not limited to, a document issued by the Bureau of Indian Affairs, Bureau of Indian Education, contract school, parochial school, or state operated school; and
- 4. Completed W-9 Form that is signed by the applicant.

Navajo School Clothing and Supplies Guidelines

Section One: Purpose

- A. The Navajo Family Assistance Services (NFAS) provides financial assistance for eligible school age Navajo children to purchase clothing and supplies, of their choice, in an effort to promote school attendance, encourage academic performance, and support confidence.
- B. The NFAS is the lead agency to provide school clothing and supplies assistance for the Navajo Nation utilizing Navajo Nation and federal funding. These Guidelines will advise the applicant on how to apply for financial assistance. The applicant is a parent or legal guardian of the child(ren).

Section Two: Eligibility

- A. The following requirements must be met for determination of eligibility:
 - 1. The child must be between 3 to 18 years of age on the date the applicant submits an application.
 - 2. The child must be enrolled member of the Navajo Nation.
 - 3. The child must be enrolled in school, including home, or virtual learning.
 - 4. The child must be enrolled in child care, Head Start, Pre-Kindergarten, Pre-school, and grade K through 12 for the current academic school year.
- B. An applicant is only eligible to receive financial assistance from one of the following:
 - 1. NFAS' Navajo School Clothing and Supplies; or
 - 2. Navajo Department for Self Reliance's TANF school clothing benefits.
- C. The applicant cannot simultaneously apply or receive funding from the funding sources provided in paragraph (B) of this section.
- D. By submitting an application and receiving financial assistance, the applicant self attests that the NFAS funding will be used for the purposes outlined within these Guidelines and that the information submitted is true and accurate.

Section Three: Required Documents

The applicant must submit the following required documents to NFAS:

- 1. The child's Certificate of Indian Blood;
- 2. The child's valid social security card;
- 3. A document on official school letterhead verifying the child is enrolled for the current academic year, or appropriate documentation verifying the child is home school or virtual learning such as, but not limited to, a document issued by the Bureau of Indian Affairs, Bureau of Indian Education, contract school, parochial school, or state operated school; and
- 4. Completed W-9 Form that is signed by the applicant.

Section Four: Financial Assistance

The financial assistance for Navajo School Clothing and Supplies shall not exceed \$250.00 per eligible child for the current academic year.

Section Five: Appeal

If an application is denied, a written appeal for reconsideration must be submitted to the NFAS Senior Programs and Projects Specialist (SPPS) within ten (10) working days of receipt of a denial letter. The written appeal shall outline the reason(s) for which the applicant is disputing the denial of an application and should include supporting document(s), if any. The NFAS SPPS' decision will be final.
