Camptonville Union Elementary School District has spent the past 2 months engaging various stakeholder groups in our community soliciting ideas, needs and wants to develop a cohesive plan for supporting student learning and engagement, prevention and mitigation, and address the impact of lost instructional time. To that end, we have specifically engaged our community in the following ways:

Staff Engagement: School staff both certificated and classified met on August 17th as part of our regular back to school staff meeting. At this meeting, ESSER III funding amounts and regulations were shared with the staff and a short discussion about needs was had. After the meeting, the staff was invited to provide specific needs in writing to the superintendent for programs, supplies or ideas on expenditures for the ESSER III funding. Multiple responses were returned to the Superintendent as of September 1st.

Parent Engagement: At our annual Back to School night on August 25th, the Superintendent met 1 on 1 with approximately 30 families to solicit ideas, concerns and desires surrounding lost instructional time, best practices for student support and ways to ensure their students were supported. Additionally, on September 3rd, a "coffee with the Superintendent was held to solicit feedback from the parents about how to expend ESSER III funding.

School Site Council (SSC): Our first SSC meeting was held on September 21st. A specific agenda item of ESSER III funding was reviewed and SSC feedback was collected.

Special Education: The Superintendent met with the head of special education for the district and parent representative(s) from school special education program to ensure their needs were address and their feedback solicited for ESSER III.

Camptonville Community Partnership (CCP): The CCP is the lone community partner with ties to CUESD. They provide and support a parental co-op preschool program and provide support to members of the community through a variety of resources. The CCP is housed on the CUESD campus and the Director of the CCP meets with the Superintendent regularly to discuss needs of the campus, community and families. Via these conversations, discussion of ESSER III and needed supports have been recorded.

CUESD School Board: The CUESD school board meets monthly, and has been kept current on ESSER funding and projects. All board members have been provided with up-to-date information about ESSER III, the process for procuring and disbursing funding, and have been asked to provide the Superintendent with any specific needs which they believe could be supported via ESSER III.

A public hearing is to be held on Sept 16 for review of this plan.

#### A description of how the development of the plan was influenced by community input.

After reviewing the input from the community and examining priorities based on greatest academic and social-emotional needs, a few trends appeared. Greater than 50% of all respondents noted that a reconstruction of our playground was desperately needed to ensure that students have access to physical play activities including strengthening their bodies and minds with physical play and growth. The teachers overwhelmingly requested new digital Promethean Boards to expand upon their capacity for both direct instruction in the classroom and access to independent study for students who are not able to be present. Additionally, teaching staff expressed the need to expand our afterschool program so that all students could have access to it and starting an enrichment based Saturday School program to support enriching, hands on education for all students. In addition to Saturday School, our community partners and staff agreed that the expansion of our elective program to include more real-world hands on educational experiences would benefit all students grade 3rd-8th. In discussing needs with our special education team (staff and parents), the desire to have access to more adaptive equipment in the special education classroom, separate from direct IEP identified items was a top priority. The discussions with the maintenance and facilities department yielded responses in regards to improving safety at the school. The improvement to our emergency notification and alert systems along with improving facility design were top priorities.

In all conversations with parents, staff and community members a common theme continued to appear: ensure that whatever is done, it is directly accessible to students.
