3. Consideration of approving the recommendation of the Finance Director, Mrs. LeGros, to issue the following stipends:
1. One-time, \$500 Retention Stipend. Eligibility requirements are as follows: All school level teachers, counselors, librarians and administrators that received a successful final evaluation under the LEGACY/LEADS Evaluation Rubric, were employed with JDPSB the previous school year, returned for the current school year, and employed as of January 5, 2026 will receive the retention stipend. The approximate cost for this stipend is \$230,000 and will be paid by the General Fund.

2. State mandated, differentiated compensated stipend. Eligibility requirements are as follows: Teachers working in state labeled critical shortage areas listed as K-12 Sped, 6-12 Math and 6-12 Science; 3+ years HE VAM; Teacher Leaders. If the specific criteria is met stipend values determined by Assistant Superintendent, Mr. Oustalet are based off of yearly allocation amount and number of eligible employees. The total cost of these stipends will be \$97,500 paid through the General Fund but allocated by the state.
