Information Items

A. District's Middle School Students Participate in S. C. Bar Regional Middle School Mock Trial Competition

Congratulations were extended to students, coaches, attorneys, and coordinators who participated in the S. C. Bar Regional Middle School Mock Trial Competition held in Conway, SC, on November 3rd. Participating schools were C. E. Murray Middle, Hemingway M. B. Lee Middle, and Kingstree Middle. The Board Chair presented Certificates of Recognition for each of the three schools, to students, coaches, principals, and attorneys at the meeting.

B. South Carolina School Boards Association's Presentation

Mr. Duane Cooper, Legislative and Advocacy Coordinator for the South Carolina School Boards Association, presented a summary of recent state legislative actions. He also addressed questions and concerns from the Board Members, regarding his presentation.

C. WCSD Administrator Receives Commendation from the US Department of Education

Ms. Angela McClary-Rush, Coordinator of English/Language Arts & Social Studies was congratulated by Board Members for having served as a 2011 U. S. Department of Education Teaching Ambassador Fellow.

D. Instruction

Dr. Bernice Davis-Cooper, Mrs. Delaney Frierson, and Mr. Mark Easterling presented information on the district report card. Instructional staff members responded to Board questions and concerns. Dr. Jefferson-Barnes commended principals and school level employees for improving the report card from below average to average.

E. Finance

Ms. Christine Green presented the Revenues and Expenditures statements for the month of October 2012, which were \$1,708,646.92 and \$2,486,078.67, respectively. She addressed a Board Member's concerns regarding a stolen district-owned vehicle, class size reduction, consolidation of district-level positions, and issuance of payroll checks bi-monthly.

Mr. Del Brown, from McGregor and Company, presented the school district's audit report for school year 2011-2012. He indicated a fund balance of \$3,691,000 at the end of school year 2011-2012. Mr. Brown said that \$689,000, of the fund balance, had already been used in 2012-2013, leaving roughly \$3,000,000. With reference to twice-a-month pay, he explained that the district's yearly expenditures of \$50,000,000, divided by 10 active months, equaled \$5,000,000; which is needed each month to operate the school district. He said the district is not financially able to return to the twice-a-month pay. When asked how soon the district would reach \$5,000,000, Mr. Brown indicated, no time soon; and agreed that the current \$3,000,000 fund balance would be used to help balance the budget for school year 2013-2014.

Mr. Brown highlighted various items in the audit report. He noted in 2010 the district had 11 deficiencies; in 2011 there were three deficiencies; and in 2012 there were no deficiencies.

Executive Session

A motion was made by Rev. W. C. Henryhand and seconded by Mr. Joseph Lee that the Board convene in Executive Session to discuss items listed on the agenda.

A. Discussion of Election, Transfer, Termination, Retirement and/or Resignation of Staff

The motion was carried unanimously, (6-0). The Chair did not vote. The Board convened in Executive Session at 7:54 p. m.

Open Session

A motion was made by Rev. Alfred Darby and seconded by Mr. Joseph Lee that the Board convene in Open Session to vote on any matters per Executive Session discussion. The motion was carried unanimously, (4-0). The Chair did not vote. The Board convened in Open Session at 8:10 p. m.

A motion was made by Rev. Alfred Darby and seconded by Mrs. Barbara McKenzie to accept the resignations of Ms. Tabitha Courtney and Ms. Robin Edens. The motion was carried unanimously, (4-0). The Chair did not vote.

A motion was made by Rev. Alfred Darby and seconded by Mrs. Barbara McKenzie to accept the superintendent's recommendation for the termination of employment of a continuing contract teacher, subject to the Board's duty to review the matter on the merits pursuant to state law should the individual request a hearing. The motion was carried unanimously, (4-0). The Chair did not vote.

A motion was made by Rev. Alfred Darby and seconded by Ms. Norma Bartelle to accept the administration's recommendation to employ the following personnel for the 2012-2013 school year: Ms. Kenyatta T. Bell, Mr. Omar Y. Hilton, and Ms. Luriell Royster. The motion was carried unanimously, (4-0). The Chair did not vote.

<u>Adjournment</u>

A motion was made by Mr. Joseph Lee and seconded by Ms. Norma Bartelle to adjourn the meeting. The motion was carried unanimously, (4-0). The Chair did not vote. The meeting adjourned at 8:11 p. m.
