

## **Questions regarding IT24.11.19.1 Computers**

## QUESTIONS

**1.** On page 22 of this bid the vendor application is requesting our SPIN number can you tell me if the payment method for this bid is E-rate if so will the billing be SPI or Bear?

- A. These are NOT E-Rate Eligible items, so a SPIN number is NOT REQUIRED for this RFP/Bid.
- 2. Item 1 Student Device Option 1 (14", i5, 8/128) Is WiFi 6e required?
  - A. Page 16 of the RFP/Bid states: Equivalent bids will be accepted as long as they are an equivalent for these specifications. Vendors may submit alternative equipment as long as the equipment is an equivalent make and model. Evaluation of items responded with will be rated on the rubric on page 14 of the RFP/Bid.
- 3. Item 2 Student Device Option 2 (14", i5, 8/256)) Is WiFi 6e required?
  - A. Page 16 of the RFP/Bid states: Equivalent bids will be accepted as long as they are an equivalent for these specifications. Vendors may submit alternative equipment as long as the equipment is an equivalent make and model. Evaluation of items responded with will be rated on the rubric on page 14 of the RFP/Bid.

**4.** Item 3 – Student Tablet (11", Touch, N200, 8/128) – Can we propose a 2-in-1 device vs a true tablet?

A. Page 16 of the RFP/Bid states: Equivalent bids will be accepted as long as they are an equivalent for these specifications. Vendors may submit alternative equipment as long as the equipment is an equivalent make and model. Evaluation of items responded with will be rated on the rubric on page 14 of the RFP/Bid.

**5.** Item 3 – Student Tablet (11", Touch, N200, 8/128) – Is ethernet/RJ45 port required?

A. Page 16 of the RFP/Bid states: Equivalent bids will be accepted as long as they are an equivalent for these specifications. Vendors may submit alternative equipment as long as the equipment is an equivalent make and model. Evaluation of items responded with will be rated on the rubric on page 14 of the RFP/Bid.

**6.** Battery Extensions: Is Hamblen wanting pricing for 1 year of battery coverage, or 1 additional year of coverage = 2-year coverage?

 A. Pricing should be for one(1) additional year of warranty -Extended battery warranty by 1 year per battery (Ability to add multiple years. Cost should reflect one(1) year additional cost.) The district may wish to purchase multiple years of additional warranty on a battery of a device to extend the warranty of the battery in the device.

**7.** Accidental Damage Protection: Are there requirements on # of claims per device per year?

A. There should be a standard number of claims per device/per year. Please state any restrictions/benefits of protection in proposal.
