**REMOTE LEARNING DAY
(UPDATED)**

January 26, 2026

Dear Parents, Guardians and Students,

With the forecasted dangerously low temperatures for Tuesday, January 27, 2026, Frazier School District will be utilizing a **Remote Learning Day**.

I am resending this correspondence, originally sent in earlier in January, so you and your child(ren) are better prepared for tomorrow's learning experience.

The Frazier School District Board of Directors has approved the implementation of remote learning days only after all make-up days included in the school calendar have been utilized. These remote learning days are intended to be asynchronous, meaning that instruction will not be delivered through live sessions on platforms such as Google Meet or Zoom. Instead, students will proceed with their work at their own pace throughout the day.

Teachers will be available to assist and answer student questions during designated times from 10:00 am to 11:00 am and from 1:00 pm to 2:00 pm each day. This time is allocated for support rather than direct instruction. Teachers will provide a Google Link in their respective Google Classrooms and will be accessible during these periods.

During remote learning days, teachers will be required to provide your child(ren) with instructional material and/or assignments that are relevant to where they are currently working in the curriculum. For many, posting these assignments in Google Classrooms will be sufficient, however for those students without internet or access to a computer device, they should have been provided a hard copy of the assignment in advance.

- **Student Attendance:** Students are expected to submit their assignment(s) the day after a remote learning day in order to receive credit for attendance and/or credit for the assignment.
- Teachers, school nurses, and school counselors will be available from the hours of 10:00 am - 11:00 am, as well as 1:00 pm - 2:00 pm each day to respond to students' questions via Google Meet.
- **Setup Of the Day/Instruction:** Asynchronous
 - ❖ Lesson and/or assignments posted by (9:00 am)
 - ❖ Teachers will be available by email throughout the day.
 - ❖ A student who does not have online access or their teacher is absent should complete a packet assignment that was sent home prior for completion.
 - ❖ Teachers will be available from the hours of 10:00 am - 11:00 am, as well as 1:00 pm - 2:00 pm each day to respond to students' questions via Google Meet.
- **Scheduled Make Up Days**
 - January 19, 2026: Martin Luther King Day (School closure on December 2, 2025)**
 - February 16, 2026: President's Day (School closure on January 20, 2026)**
 - April 2, 2026: Easter Break (School closure on January 26, 2026)**

If there are any questions or uncertainties about remote learning days, please contact your building principal. Administrators will be present at their buildings tomorrow to address any such calls or inquiries. Appreciation is extended to everyone for participating in this endeavor. For further questions or concerns, please contact your teacher or building principal.

NOTE: In a circumstance where Frazier School District would move from a two hour delay to a Remote Learning Day, the same schedule should be followed.
